10 YEAR WARRANTY

EXPRESSED OR IMPLIED (INCLUDING BUT NOT LIMITED TO ANY REGARDING THE MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE), REGARDING THE PRODUCT WHICH IS THE SUBJECT OF THIS WARRANTY.

All products manufactured by Patton Aluminum Products, Inc. are warranted to be free of material defects for a period of ten (10) years from the date of purchase. All work to be completed in a professional manner according to standard practices. Any questions concerning workmanship must be reported within **10 Days** after completion of work or will be subject to service charge.

Under such warranty, the cost of material only to replace any part determined by the company to be defective shall be pro-rated between the company and the purchaser as follows:

The company share of such replacement cost shall be one hundred percent (100%) during the first year of the warranty period and will thereafter decrease at the rate of 10 percent (10%) per year during the remainder of the warranty.

This warranty does not cover damage resulting from fire, lightning, hail, wind, earthquake, ice damming leaks, floods, hurricane force winds, Tornadoes, vandalism, animals, trees, falling objects, normal weathering or other acts of nature misuse, abuse, chemicals, fumes, vapors, or other causes beyond the control of Patton Aluminum

Leaks due to any type of Condensation on any Non Insulated Product That is Enclosed. These issues are sometimes mistaken for leaks. Distortion, Expansion, or Contraction of the Roof(s) caused by faulty original construction or design of building components, including Parapet Walls, Copings, Chimneys, Skylights, Vents, Valleys, or Roof Deck.

Popping noise and very loud popping can be caused by expansion and contraction of aluminum and can be extreme in some cases.

Factory installation done by Patton Aluminum Products only is guaranteed for a period of 90 days, anything over 90 days will have a minimum service charge.

Under no circumstances shall this warranty extend to damages or defects caused by defects in adjacent structures or by defects in the foundation or the supporting structures or ground upon which any structure containing products provided by Patton Aluminum Products, INC. are installed, erected, or incorporated. It is expressly understood that the purchaser is and shall remain solely responsible for providing a good and sufficient foundation, ground and adjacent structure and that any damage to the purchaser's property caused by defects in the same shall be and shall remain the purchaser's responsibility. The determination of whether the foundation, underlying ground and adjacent structures are good and sufficient shall, at all times, be the responsibility of the purchaser alone and the purchaser acknowledges that he/she/it has made sufficient inquiry and received adequate information to make such determination.

Any intentional or negligent act on the part of the Owner or Third Party including, but not limited to: Misuse, Traffic, Tenting, Installation of Christmas Lights, Clogged Valleys or Debris buildup, Installment of or damage caused by Roof Top Appurtenances, including without limitation, Lightning Protection Equipment, Antennas, HVAC units, Pitch Pans, Framework or Supports for Signs, Piping, Conduit or Sprinkler Systems or Products supplied and/or Installed by others.

This warranty does not exceed other manufacturer warranties for materials not manufactured by Patton Aluminum Products, such as windows, doors etc. Patton Aluminum Products does not warrant Skylights or Custom Paint. We do not warrant leaks between the attachment point and the cover. We will flash to the best of our ability, but we will not service any leaks at the attachment point.

Patton Aluminum is not responsible for voiding other manufactures warranties For mounting patio covers and awnings to existing structures.

Warranty will be null and void if materials do not follow guidelines set forth by Patton Aluminum, minimum drop, Engineered post requirements, Engineered downspout requirements, Engineered snow loads etc.

The Warranty shall not cover:

- a) Damage, defects or deterioration due to normal use, wear, or exposure to elements.
- b) Damage or defect resulting from misuse, neglect, alteration, accident or negligence.
- c) Repairs, alterations/paint or installations of accessories which have an adverse effect on the operation, performance or durability of the unit or its components.
- d) Repair or replacements of the product or material that has been modified, altered or effected with respect to the intended use of the product.
- e) Repair or replacement as a result of the use or operation of the product in a manner which is not in accordance with the instructions as specified in the owner's manual or other instructions provided by Patton Aluminum.

Cleaning Hints

Pollutant fills, caused by auto or local industry emissions, can cause an acid type build -up on the baked enamel painted surface. Mix a few tablespoons of dish washing liquid with water and apply liberally to all exposed surfaces.

Rinse with clean water. Do not use abrasive or solvent type materials or paint remover. These materials can soften, dull, or remove the baked on enamel finish.

To Remove Mildew -

Black spots on the surface of your aluminum products may be caused by mildew. Watch carefully for rain protected areas such as the underside of your awning or enclosure roof. To eliminate mildew, purchase a product specifically designed for removal of mildew stains on painted surfaces.

Protecting the Finish -

A quality automotive wax can be applied to help preserve the factory finish on your aluminum products. Clean and dry the surface and apply as per manufacturer's directions. Just as the finish on your automobile requires protection, your painted aluminum products will benefit from the same.

Use Caution While Cleaning -

Be careful when cleaning any aluminum product, as there may be sharp edges and corners which could cause harm. The use of protective gloves when cleaning aluminum products is highly recommended.

Purchaser consents to and agrees that this warranty shall be interpreted and construed pursuant to the laws of the State of Ohio only. Alterations/Paint can cause excessive heat, condensation and interlock issues on seams. Purchaser further agrees and stipulates that the exclusive jurisdiction for resolving any disputes arising out of the purchase, installation or use of this product shall be in the Court of Common Pleas for Clark County, Ohio.
