**Declaration:** I hereby agree to be bound by the rules and regulations of the New Forest Polo Club and the New Forest Polo Club Ltd (hereafter both referred to as 'NFPC') and the Hurlingham Polo Association (HPA) and specifically this disclaimer for so long as I am participating in any activity associated with or run by the NFPC. For clarity this includes social, playing, and other general visitor admission to NFPC.

I recognise that polo is a dangerous sport, which can result in serious injury, disability or death, and that there are risks and hazards to all present at NFPC and any polo related activities organised by NFPC whether I am a participant, groom, player, umpire, official, spectator or other and whether a polo activity is in progress or not, and I do so entirely at my own risk. Therefore, I indemnify and hold harmless the directors, committee members and volunteers of NFPC against any liability or other obligation for any kind of injury, disability, accident, death, loss and/or damage suffered by myself, my animals or any person or property whom I bring to NFPC, its grounds or property. All personal property kept, placed or left on or about the site is at my sole risk as to loss, theft, injury or damage.

I recognise that all activities involving horses carry risk as they can be unpredictable and dangerous. I agree to take directions and follow all instructions given by any Officials or Committee Members of NFPC, who will aim to ensure my safety. I understand that failing to do so may result in injury, death or loss.

I understand and accept that an official at NFPC may terminate any activity at NFPC at any time for my own safety and the safety of others. I understand that it is my own responsibility to check all documentation for NFPC before participating in activities. I understand that all children under the age of 18 must be accompanied by a parent or guardian when on-site or participating in any activities at NFPC. I understand that parents and guardians are responsible for their children at all times whilst participating in any activity associated with or run by the NFPC.

I hereby confirm that I do not suffer from any condition which would affect my capacity to participate in these activities and I will not hold NFPC responsible for any injury, accident or death suffered while at the club or for any act of negligence of any kind. I will also not hold any first aider or other medically qualified individual liable for any act or omission performed in the event of an accident or injury. I hereby confirm that I have obtained qualified medical approval for known medical conditions before participating in any activity at or run by NFPC. I hereby confirm that I am a competent driver with a valid, up to date driving license and that all vehicles I bring to the premises of NFPC are fully insured and in particular when reversing and maneuvering I will ensure I am observant of pedestrians, animals and vehicles in the surrounding area.
