The buyer, _____ agrees to place a NON-REFUNDABLE deposit on a puppy of their choice. The puppy shall remain with the breeder, Jessica Harloff, until the agreed date of pickup on: _____

I am aware that my deposit of \$500 is non-refundable should I change my mind and decide I do not want or am unable to take or pay the outstanding balance of _____ for the puppy by the agreed pick up date. I am aware if the \$500 non-refundable deposit is put down before the puppy is 8 weeks of age. That the said puppy has to be picked up at 8 weeks of age. If the \$500 non-refundable deposit is put down after the puppy is 8 weeks of age, that the deposit holds the said puppy for 7 days. If the said puppy isn't picked up at the proper time, it will go back available.

I am aware that if I ask Smokey Mountain Chihuahuas to hold my puppy longer, then I will pay a boarding fee of \$100 for every week said puppy stays. This is to be paid in advance and is a separate cost from the puppy. This is to cover the extra vet bills, food and Smokey Mountains time.

I am aware that if Smokey Mountain Chihuahuas meets a hour from their home, then there is a

\$50 "CASH" transport fee. This is to cover their gas to and from the meeting place

I am aware that Smokey Mountain Chihuahuas owner Jessica Harloff, may not always be able to meet in person. This is due to event that she has a momma dog due any time, extremely young puppies or an emergency with one of her dogs. At this time she will have either her mom "Leasia Harloff" or husband "Kenny Hubbard" meet us with our puppy. That I am to hand over the puppy's remaining balance, transport fee and boarding fee "If there is one" over to them.

The buyer, _____ understands that Smokey Mountain Chihuahuas is licensed with the state of Tennessee. Therefore, they have to add Tennessee's Sale Tax 9.75% to the asking price of the said puppy.

If puppy is to be transported, buyer agrees to pay any shipping cost in full before transportation can be booked. Buyer agrees to pay IN FULL before puppy leaves with pet transporter no later than 3 days PRIOR to scheduled pick up. Buyer understands that if shipping is needed that this cost is separate from remaining balance of puppy and should be paid separately. Shipping rates differ and should be discussed before this contract is signed.

I will accept this deposit amount of \$500 to hold the puppy until the agreed pick up date. If the puppy should no longer be available due to illness or accident, I agree to refund the deposit money in full.
