- **Idle / underutilized site containers**, or
- Containers that can be **made available for a period of up to 3 years**

These containers would help us:

- Start operations quickly without heavy upfront construction
- Optimize costs in the early phase
- Build a functional campus while permanent infrastructure is planned

We are currently seeking **initial ecosystem support** from responsible builders who understand site realities and workforce challenges.

How the Support Will Be Used

- Containers will be repurposed for classrooms, hostels, and labs
- Used exclusively for educational and child welfare purposes
