

INTELLIGENCE PRIORITIES

Operation: Expose & Disrupt Phase II Threat Network

1. IDENTIFY JUDGES UNDER PRESSURE OR BRIBERY

Objective: Map the judicial compromise

Steps:

- Investigate sudden financial changes in key judges' lives (home purchases, debts cleared).
 - Cross-reference judicial rulings with America First PAC-linked donor activity.
 - FOIA requests for emails, meeting logs, or scheduling with White House, AFPI, and state attorneys.
 - Coordinate with Senate Judiciary Committee Democrats for hearings and public exposure.
 - Alert DNC Legal to begin civil challenge coordination.

2. TRACK MILITIA LEADER MOVEMENTS & STOCKPILING

Objective: Monitor arms build-up and extremist mobilization

Steps:

- Use drone and satellite surveillance to document movement to known compounds.
 - Monitor Telegram, Gab, and Truth Social for coded rally calls.
 - Partner with veteran whistleblowers for insight on leadership org charts.
 - Report intelligence to Democratic Governors and request National Guard contingency plans.
 - Provide real-time updates to Homeland Security Democratic Caucus members.

3. EXPOSE COORDINATION BETWEEN STATE LAWMAKERS & AFPI POLICY MEMOS

Objective: Prove unlawful governance coordination

Steps:

- Obtain internal memos from state capitol insiders and legislative aides.
- Compare state bills with AFPI templates for exact-match language.
- Coordinate with the Democratic Legislative Campaign Committee (DLCC) to pressure statehouse media coverage.
- Push for state-level ethics investigations and lawsuits via DNC and ACLU legal arms.

4. INFILTRATE ENCRYPTED COMMS OF “DIGITAL LIBERTY FRONT”

Objective: Intercept and decode insurgent tech operations

Steps:

- Recruit ethical hackers and cybersecurity experts through progressive tech coalitions.
- Target backend infrastructure on Matrix, Signal, and ProtonMail.
- Identify key usernames and aliases for ongoing surveillance.
- Share intel with FBI cybercrime unit contacts via Democratic liaison channels.
- Brief Congressional Dems on House Intelligence and Cybersecurity Committees.

5. CONTACT & COORDINATE WITH KEY DEMOCRATIC LEADERS

Objective: Create a united front against authoritarian actions

Steps:

- **Congress:** Deliver briefing packet to Democratic House & Senate leadership, especially Rep. Jamie Raskin, Sen. Sheldon Whitehouse, and Rep. Dan Goldman.
- **Governors:** Urge Democratic governors to enact emergency protocols and reject participation in “Christian Governance Index.”
- **DNC:** Request rapid-response comms team to counter propaganda and fund whistleblower protection.
- **Senate Committees:** Request hearings in Senate Judiciary, Armed Services, and Homeland Security.
- **Partner orgs:** ACLU, Brennan Center, SPLC, and Center for Constitutional Rights for legal and media support.
