

## Application for Full Patch UBOC - Texas Chapter

Eligibility / Process and requirements for Unified Body of Christ Full Patch:

Patch Applicant must have read, understood and agreed by signing of the UBOC Covenant of the UBOC General Membership application which explains what the Unified Body of Christ is About, our Mission Statement, What our Logo/Patch is about and the Description of our Ministry including Instructions for Christian Living.

A Full Patch Applicant must have been a part of the Unified Body of Christ ministry and attended our meetings and ministry functions for at least 90days. The only exception to this is if the board brings a recommendation of an Applicant who is "Patching Over" or who is coming from another ministry / Church by Pastor's Letter of Approval where the Applicant has been serving in an Active Ministry Capacity at which the UBOC will consider the recommendation of the former Ministry or Pastor, but must be Approved by our board members. The purpose of the waiting period is for the Applicant and for the UBOC Board to make sure they are ready to take on a ministry position that comes with a full patch.

As signed by your covenant, ALL UBOC Members are expected and agree to conduct themselves in a Christ like Manner. At No such time will Alcohol or drug abuse be tolerated. You are representing Christ and the UBOC Ministry and must conduct yourself according to what the Word of God teaches as a disciple of Christ and minister of the gospel.

As a Fully Patched member of the UBOC, you realize and fully understand that by Putting this patch on your back, you are stepping into a ministry function as the bible speaks of in 1 Peter 4:10-11; 1 Corinthians 4:1-7 and 2 Corinthians 6:4-10 – We are ALL called to minister in various forms. **The UBOC expects its members to conduct themselves as a minister understanding the World is watching you and what you do is a reflection of how they view Christ. "We shall be known by our fruit."** 

As a Fully Patched member, you understand that you are expected to attend and participate in our meetings, services and ministries.

Each Member understands the ministry and the risks involved, if they ride a motorcycle or other vehicle, ride a horse, or other animal or operate machinery it is at his/her own risk, the member understands all

risk involved in places the ministry may go to serve and do so of their own free will and shall indemnify and hold harmless the UBOC, its members and all associates.

The Name, all emblems, logo's and designs are the sole property of the Unified Body of Christ Organization. The Patch and Logo cannot be reproduced without the expressed written permission of the UBOC Organization's Board of Directors as it is copyrighted material.

Each approved applicant is responsible for the purchase of his or her own patch or patches. The money will be paid to the UBOC for the patches and cost to have sewn on the vests or jackets will be paid either to the UBOC, if the ministry has them sewn on or directly to the person sewing the patches. The UBOC Patches must be sewn in like manner and location so they all conform to the same look as all the Men's and Women's Patches on the vests or jackets. The UBOC member understands that these patches remain the property of the UBOC. If, at any time, the applicant decides to leave the ministry on his/her own accord, ALL UBOC patches will be returned to the UBOC. If the applicant is asked to turn in his/her patches because of conduct, the applicant or applicants will do so voluntarily. Reimbursement of the patch will be at the discretion of the UBOC Board of Directors depending on the circumstances, ie., if the member is leaving because they are moving or legitimate cases such as this.

NO OTHER PATCHES ARE TO BE DISPLAYED ON THE BACK OF THE VEST OR JACKET WITH THE UBOC PATCH UNLESS AUTHORIZED IN WRITING BY A UBOC BOARD MEMBER. WE WANT TO KEEP THE BACK OF THE VESTS AND/OR JACKETS UNIFORM AND CLEAN. NO VULGUR OR INNAPROPRIATE PATCHES WILL BE TOLERATED ON A VEST WITH UBOC PATCHES.
