Per Family Fees**

Current Member Fee (non-refundable)	\$ 250.00
New Member Fee (non-refundable)	\$ 500.00
Work/Pay	\$1600.00 or 40 Hours work time

Each contract account will be assessed \$1600.00 per contract, payable April 30, 2027, unless documented proof of 40 work hours satisfactorily completed is provided on or before April 30, 2027. \$1600.00 or 40 hours of work time will be completed as follows:

---5 Work Hours completed or \$200.00 must be paid before student may attend the first day of school

---15 Additional Work Hours or \$600.00 must be paid by Dec. 31. Students may not return to school after Dec. 31 if the 15 work hours or \$600.00 has not been met.

----The remaining 20 hours or \$800.00 must be worked between January 1st and April 30th or \$800.00 will be invoiced after April 30th to your account.

For each work hour not satisfactorily completed and documented, a fee of \$40.00 per hour will be billed to that contract account.

****Fee can NOT be paid by NCSEAA and must be paid before contract can be submitted to the Board for approval.**
