



## In-Home Pet Boarding Policies and Release of Liability

THIS AGREEMENT is entered into by and between Spoiled Tails LLC and Pet Owner:

- **WAIVER OF LIABILITY:** I (Pet Owner) represent that I am the legal owner of the above named dog(s) and I assume all risks, damages and responsibility to your home during any point that Spoiled Tails is in your home. Any injuries or damages with pets will be covered through Spoiled Tails LLC. Any damages in home that happens in the presence of a Spoiled Tails employee will be covered through Spoiled Tails LLC.
- **IN HOME CAMERAS:** Any cameras in your home need to be released and made known to Spoiled Tails LLC. If in-home cameras are not brought to the attention of Amanda Sula, Owner, these will be moved by Spoiled Tails employees for privacy. Cameras directed to pet's kennel / bed are not required to be turned off during in-home boarding. Cameras in the following rooms are required to be turned off during the in-home boarding period for privacy reasons:
  - Any bedrooms
  - Bathrooms
  - Living / Family room
- **PAYMENT:** All payments need to be made to Amanda Sula. Payment options include cash, check, venmo or zelle. Payments must be paid in full the day of owner departure.
- **SPOILED TAILS EMPLOYEES:** Spoiled Tails employees can / will accompany Amanda Sula, Owner, throughout duration in in-home boarding for safety purposes. Employees will assist Amanda Sula in any in-home care responsibilities throughout duration of boarding. The following employees will be listed below for owner's knowledge:

  - Clare Ziemianski

If an employee will be needed, Owner will be aware prior and will either have an official meet and greet, phone call, or video chat. Dependent on owners wishes.

- PHOTO & VIDEO RELEASE: We love to post pictures and videos on our social media and website! Owner agrees to allow Spoiled Tails LLC to use pet's name and any images taken during boarding in any media, marketing, advertising, trade or promotion materials without compensation. Owner releases to Spoiled Tails all rights that Owner may possess or claim to such image, likeness, recording, etc.

- FLEA/TICK FREE: All animals must be flea/tick free. Should an animal be observed to have fleas or ticks, a flea/tick bath treatment will be applied and charges to the owner at a rate of up to \$100.00 depending on severity and size of dog.
- FOOD/MEDS: When boarding overnight, Owner agrees that it is the Owner's responsibility to leave adequate supply of food and medication for the Owner's animals during the entire time of boarding stay with Spoiled Tails LLC. Should the food/medication need replacement, Owner authorizes Spoiled Tails to purchase replacement and Owner will reimburse Spoiled Tails LLC for the actual food and medication costs plus up to \$25.00 time/distance trip fee (per occurrence).
- CANCELLATION: Cancellations must be done 48-hours prior to boarding date. If cancellation notice is less than 48-hours an amount of up to 50% of boarding cost will be invoiced.
