OJT Instructions

On the Job Training is based on the principal of learning by doing. i.e. the worker learns the job while performing within the actual work environment. Employees also get a hands-on experience using machinery, equipment, tools, materials, etc. to face challenges that may occur during the performance of the job. The trainer will mentor the trainee through demonstrations, supervised practice including verbal instructions and assessment of skills prior to signing the Trainee off for independent performance.

To qualify on this OJT, trainee must complete the following steps:

- 1. Both the trainee and Trainer shall review the and verify all prerequisite Training and Qualifications are complete for both the Trainer and the Trainee.
- 2. Trainee must train on the related documents in Master Control prior to starting OJT observations of demonstrations and performed assisted
- 3. Review this OJT Training Material for familiarity and understanding of the content located in the Learning Objectives, Related Documents, and Background & Learning Content sections.
- 4. Document the Trainees prior experience, training and /or education in related tasks to justify the duration of Demonstrations and Practice prior to having the Trainee complete the performance evaluation.
- 5. The Trainer shall mentor the trainee through demonstrations and closely observed practice (performed assisted) of the associated tasks and steps until the Trainee is competent and comfortable to perform independently without outside guidance. Document all instances of "Demonstrations" and "Performed Assisted" on the associated forms.
- 6. The Trainee shall complete a performance demonstration of the tasks and steps associated with this OJT, and the trainee shall be able to verbally explain the steps and rational behind the tasks and steps being performed. The Trainer shall observe and verify that all tasks and steps are completed accurately and independently, and the trainee can explain what they are performing and any criteria specific to the tasks. *The trainer shall not interfere or assist with performance unless to avoid a safety risk or deviation, in this case the trainee would fail. *
- 7. Complete all associated paperwork for this OJT and the Trainee shall upload a scan into Master Control and sign off on the assigned training Task.
- 8. The Trainees line manager will be required to verify in Master Control that the OJT documentation was successful uploaded to the training task, prerequisites are met, performance was acceptable to perform independently, and that documentation is acceptable. The Course is considered complete when all approvals and verifications are complete.




Figure 1: Flexicon Filler Format Set
