### A. Pickens/ Dawson Joint Resolution

Attorney Phil Landrum presented the board with the draft of the resolution that he intends on sending the attorney for the Dawson County Board of Elections. He said if the board has no changes he will send as is and the board can vote on signing once it has been approved with no changes by Dawson County.

# A. Purchase of Easy Vote Software Modules

Supervisor Godfrey gave an update to the board that the current contract with Easy Vote is due for renewal in September. She asked for a board vote to purchase the additional modules.

A motion was made by Mike Carver, seconded by Larry Brown to purchase the additional modules with the Easy Vote Software. Members Mike Carver, Terry Franzen, Rebeca Cantrell, and Larry Brown voted 4 (Yes), to 0 (No) to approve the purchase. The vote was unanimous.

# B. Resignation of BOER Member Larry Brown

Board member Larry Brown submitted his letter of resignation effective as of August 31, 2023. He said it has been an honor to serve the voters of Pickens County.

### VIII. STAFF COMMENTS

Supervisor Godfrey discussed the progress with the new GARVIS voter registration system.

Staff attended regional training in Godon County in July.

Ms. Godfrey notified the board that qualifying for the 2023 Municipal Election would begin August 21<sup>st</sup> and go through August 25<sup>th</sup> from 8:30 am- 4:30 pm for the City of Jasper, City of Nelson, and Town of Talking Rock.

Supervisor Godfrey let the board know that she would be hiring a full time Absentee Ballot Coordinator. With two part-time employees no longer working in the office, we can hire and combine the two positions into one.

Ms. Godfrey stated that she had met with the Superintendent for the Board of Education, Mr. Thomas, and he would be addressing the school board about changing the March 12 Presidential Primary Election Day to a virtual learning day for the students. Supervisor Godfrey said with the number of people expected to vote that day it is a concern to have that many people coming to the schools when the children are there. She will update the board on the status of this once Mr. Thomas gets back with her.
