- (Item 1) Call to Order was done by Edward Toledano at 7:00 pm; Invocation was said by Shirley Callahan; All attending

- (Item 2) Adoption of Agenda & Prior Months Meeting Minutes
 - o Shirley Callahan made a motioned to accept agenda and minutes, and Doug Miller second; motion passed
- (Item 3) Announcement of next meeting date of March 11, 2025

- (Item 5) City Communication updates NEGRC Letter
 - Mayor Toledano explained there were over 121 cities that were not compliant with the Georgia Department of Audits and Accounts and that the City of Maxeys is no longer a Qualified Local Government. Communication with the CPA firm of Treadwell, Tamplin & Co on January 15 allowed for all documents to be signed and request for bank records executed in order to complete the 2019 filings, which will be completed by June 2025. Each year thereafter 2020, 2021, 2022, 2023 & 2024 will cost \$4,000 for each year, for a total of \$25,000. An aggressive plan has this being completed by end of 2026.
 - Mayor Toledano explained the City could not apply for any state or federal grants until we have completed all required audits
 - Question from Mayor Pro-Tem Gorman as to if the City paid the CPA firm for the audits which were never completed; Mayor Toledano is to check on this and report back to the Council <u>at the March Meeting</u>
- (Item 6) Permit Applications Cynzia Sanchez Requesting to make an addendum to prior Building Permit adding 2 bathrooms and a new septic tank
 - \circ $\;$ Carrie Hyatt motioned to accept this addendum; Carrie Hayes second; motion passed
- (Item 7) Consent Agenda Remove Roadside Info Sign, clean out rest of City Hall inside/outback & Screen Building, Move Storage Building, Clean out old fire hall
- $\circ~$ Carrie Hayes made a motion to accept the Consent Agenda items, Doug Miller second; motion passed
- (Item 8) Committee Reports
 - Finance & Budget
 - City Finance Report for January
 - Working through the procedures and processes to streamline our financial reporting and management over the next 2 months. All bank accounts have been transitioned with new Login & Password.
 - CD Due on 4.27.25 at the Commercial Bank Roll over to an 11 month at 4% or a 5 month at 4.35%; there was
 discussion among the council members
 - Carrie Hyatt made a motion to roll over the CD at 11 months at 4%, Carrie Hayes second; motion passed
 - Donation Georgia Dual Sport
 - \$200 Donation for use of City Hall lot in back now and then. May reach out to ask for use during their event in the future. Funds were deposited to Firefly Trail
 - Software Update Consideration

- Current Quicken software is 2005 version. Needs to update to new version or change to QuickBooks or some other system. Need to utilize capability to connect to banks with software for efficiency. Carrie Hyatt is to work with Mayor Toledano to decide a recommendation to Council <u>at the March meeting</u>
- Parks & Recreation
 - Community Center
 - Barbara Cabaniss, president of the Maxeys Women's Club request permission from the Council to continue to use the Community Center at no charge considering all the work the Club does for the Community
 - Doug Miller made a motion for this request, Carrie Hyatt second; motion passed
 Mrs. Cabaniss expressed the Club's interest to plant a Moon Glow Juniper Tree as a permanent
 Christmas Tree. It was agreed we would revisit this at a later meeting of the Council
 - Anne Garner, Chair of the Annual 5k Race, requested the use of Community Center for her group at no charge, and the use of the City's Tables & Chairs located in the Fire Hall for race day. A question of ownership of the tables and chairs came up.
 - Danny Gorman made a motion to tentatively give Ms. Garner's group to use the tables and chairs in the Fire Hall once Mayor Toledano checked with the Salem Fire Department on this matter, Doug Miller second; motion passed
 - Shirley Callahan offered use of her property Apothecary Building for their meetings.
 - Carrie Hyatt made a motion for Ms. Garner's group to the Fire Hall could be used as a backup meeting place, Carrie Hayes, second; motion passed
