**Deposit of \$50.00 is due with Application.**

Installation Fee of \$1500.00 is required with new construction INSIDE city limits. Installation Fee of \$1700.00 is required with new construction OUTSIDE city limits. **\*\* An additional fee is required when a bore is required and will be priced based on distance bored.** A bore is necessary for a water line to be installed on the opposite side of the road from the City's line. The City **does not** trench or install water lines from the meter to your Home/ Structure.

Bills are due by the **15th of each month**. A late fee of 10% will be applied to any bill paid after the 15th of the month. **Accounts remaining unpaid by the 16th of the following month shall be subject to being disconnected.** Reinstatement fees after disconnection shall be \$25.00 first occurrence, \$50 second occurrence, \$100.00 third and each occurrence thereafter. To avoid disconnection, all outstanding amounts for water service, including past due amounts, currently due amounts and late fees will have to be paid in full.

A \$25.00 surcharge will be added to past due bills paid when Water Personnel is on the property to run off the water.

A \$25.00 fee will be charged for all insufficient funds which are returned checks.

When necessary to terminate water service, *please give at least five (5) days' notice prior to the desired date of discontinuance of water service to the City of Maxeys 706-759-2177.*

### Initial Water Service

Each consumer subscribing to use the water service of the City of Maxeys shall pay a separate installation fee and separate connection fee as follows:

In a development when the developer has installed the service line and appurtenances for water, the builder shall be credited 75% of the installation fee for water. There shall be no credit allowed for connection fees.

The City of Maxeys shall own and maintain the service line from the main through the curb box and the property owner shall own and maintain the connection line from the curb box to the premises served.

All work upon property owner's service shall be inspected, before it is covered, by a person employed by the City of Maxeys.
