The 2023 Maryland Legislature passed SB0760, which revised the Article on Business Occupations and Professions § 19-412 as it relates to the mandated training requirements. In accordance with SB0760 and in cooperation with the Maryland State Police, we have approved your request for approval of an In-service Training Program.

**Approval Period: 2/1/2025 - 2/1/2028**

**Upon expiration of the course, a new number must be acquired using the same procedures no later than 30 days prior to the expiration of the course.** Upon successful completion of either an in-service training program(s) totaling a minimum of (8) hours the Authorized Training Provider that is the presenter, overseer, coordinator, etc., will issue each student a Certificate of Completion.

The Certificate of Completion will provide the above program "G" number, date(s) of training, and a statement indicating the named individual successfully completed the course and have the Authorized Training Provider's signature. This certificate will be sent to the Maryland State Police by the Security Guard for application or renewal. You should maintain records of your training and attendees for verification if required.
