



Since the 2015 academic year, the regional coalition of schools known as [MCISSE](#) is dedicated to increasing the number of Middle and High School students who participate in the [National CyberPatriot](#) Competition in Michigan. In 2017 we received \$20,000 from the Michigan Economic Development Corporation to pay for 80 team registrations the same year we received Center of Excellence status with the national AFA CyberPatriot program. In 2018 we received \$100,000 from the Michigan Department of Education to administer the Michigan CyberPatriot Program. Which included training for Coaches and Mentors, education modules for the Michigan Edupath portal, A Spring celebration ceremony for all Michigan students and to fund eight summer camps across Michigan. In 2019 we received \$37,000 to put together digital badges for all Michigan students participating in CyberPatriot.

Nonetheless, our work is not completed. The CyberPatriot competition encourages hands-on STEM education and career pathways and needs to continue to receive support. Far too many local School districts and student groups across Michigan are not yet aware of the program and its advantages. With over 450,000 Cybersecurity jobs unfilled nationally, we should do everything we can to get more Michigan students into STEM education.

1. Purpose: With the objective of promoting their cooperation in academic cybersecurity education the Midwest CISSE Chapter (MCISSE) and _____ individually, also “party” and collectively the “parties” enter into the following Memorandum of Understanding (MOU)

2. Forms of Cooperation: With such fields that are mutually acceptable for the parties, the following forms of cooperation, amongst others, may be pursued hereunder.
 - A. The “parties: will conduct joint Marketing or Awareness of the Michigan CyberPatriot Program
 - B. Marketing of Sponsorship provided by the “party” or “Parties” using the sponsorship levels as a guide
