Injustice Behind Bars

Shawn has endured over two decades of wrongful imprisonment – most of that time was for crimes he himself did not commit. As a 19-year-old orphan, homeless, teenage boy, he was sentenced to 25 years to life for a crime committed under extreme circumstances – an \$80 robbery and unauthorized use of a vehicle. As a homeless, orphaned teenager who had been let down by the state, Shawn's choices were limited and desperate.

Unjust Charges and Sentences

- **7 years to life** for a kidnapping he was neither aware of nor present for.
- **25 years to life** for conspiracy to commit murder, despite having no intent to kill. Shawn was given the punishment for someone else's crimes.

Despite these harsh sentences, the reality is:

- **No physical injury was done** to any individual.
- **The only victim later repeatedly confessed to lying under oath** about the severity of the threat he faced.

A Miscarriage of Justice

Shawn's punishment mirrors those given for far more heinous crimes, including murder, despite no one being physically injured. This disproportionate sentencing reflects a grievous miscarriage of justice. Shawn's life has been deeply impacted by a system that failed to protect him when he was most vulnerable and has continued to fail him through his adult years.

Hope on the Horizon

We are hopeful that the tide is turning and that the truth of Shawn's case will lead to his rightful freedom. It is time for our government to rectify the wrongs done to Shawn and restore his freedom.
