

Parent Guidelines

- Follow the rules and regulations of the Rock Springs Avengers Soccer Club (RSASC) and pay the registration fee each season.
- Each player must purchase a complete uniform.
- Players must try out each year and are not promised a position on their respective team from one year to the next.
- Unless parents or coaches see children in imminent physical danger, they should not discuss a game situation, playing time, difference of opinion or personal issue until at least 24 hours after the fact.
- Support the RSASC on the field and off in a positive manner.
- No parent or fan shall yell criticism to a player while she/he is on the field. It takes an entire team to win or lose a game; including players, parents, and coaches.
- Parents are responsible for making arrangements to get players to and from practice and to games in or out of town.
- Players and parents are urged to attend all tournaments. If this is not feasible, they should reconsider playing for the RSASC.
- If your child will be transported to an out of town game by another family, you will be responsible for paying your child's share of the lodging bill, their meals and any spending money your children will need.
- Liability and medical waivers will be required before traveling with other parents. An adequate number of seat belts for players is mandatory for player safety. (Wyoming State Law)
- Parents are strongly encouraged to participate in all fundraisers. An additional player fee of \$25 may be assessed annually for non-participation in fundraisers. This money is used to defray tournament fees and other expenses incurred by the RSASC.
- Encourage players to do well in school. Maintaining good grades and having a positive attitude in school will carry over to the field.
- The use or consumption of alcoholic beverages by a parent is prohibited at the field before, during and after the playing of a soccer game. The use of foul language is prohibited.
- RSASC coaches, managers, and assistants are not responsible for any players at soccer fields outside of practices and game times.

A parent who has a complaint with any RSASC coach, player, or other parent may file a signed written complaint with the RSASC Board no later than five (5) days after the alleged incident.

- The President, upon receiving a signed/dated complaint shall call an RSASC Board meeting as soon as possible to address the complaint.
- The letter shall be read to the RSASC Board in Executive Session (all coaches, managers, guests, etc shall be dismissed). The RSASC Board has the right to include in Executive Session whomever it deems necessary for a fair and accurate evaluation. Invited guests shall have majority approval of the RSASC Board members present.
- The RSASC Board will decide on appropriate action to be taken.
- The interested party or parties will be notified of the RSASC Board decision.
- If the interested party or parties are not satisfied, an appeal may be filed with the RSASC President in the form of a signed letter. An Executive Session will be called and the interested party or parties will be given the right to address the RSASC Board. The Board's decision is final.
