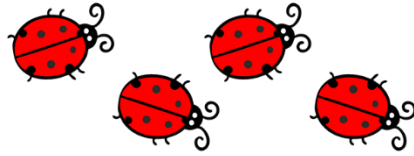
**TO BE READ AT ALL MEETINGS, ACTED UPON & FILED FOR FUTURE REFERENCE**
