Entry Fee: \$50.00, Payable to the Estill County Agrl. Fair Board, the entry fee must accompany the application. You can also pay with cash or venmo @ECfair or with credit/debit at https://square.link/u/JC44oLqp

Deadline for Entry and Practice Date/Time: August 1, 2025 at 8:00. All applications must be submitted by Google forms or email to Estillcopageants@gmail.com by the August 1st. deadline. There will be a \$10.00 late fee assessed to all applications submitted after Aug 1st. **No exceptions will be made to this policy!**

Competition: The competition will be judged on evening gown only. Judges will be looking for the lady that best reflects the Ms/Mrs age group. Judging is based on a point system and contestants will be judged on poise, eye contact, appearance (hair and makeup), and choice of gown (style, color, and fit). There will be one question, that the contestant will draw at random, on stage, to answer in front of the judges. Competition is open to all KY female residents aged 22 and above.

Ms/Mrs Estill County Fair 2025 will be selected from all participating contestants. If the winner of the Ms/Mrs Estill County Fair is a resident of Estill County, then we will not select a Miss Estill County.

Ms/Mrs Estill County 2025 will be selected from only contestants that reside in Estill County.

<u>Other details:</u> Everyone will enter through the Exhibit Hall front door next to the parking lot. Contestants will not have to pay the gate fee.

ABSOLUTELY NO ONE IS PERMITTED IN THE DRESSING ROOM EXCEPT CONTESTANTS AND ESTILL COUNTY PAGEANT COMMITTEE MEMBERS. ABSOLUTELY NO EXCEPTIONS WILL BE MADE TO THIS RULE!!

The Estill County Fair Board is not responsible for lost or stolen items or items left behind.

Rules for entry:

- 1. Contestants must have reached her 22nd birthday by October 31, 2025.
- Contestants must be a natural born female and can be single, widowed, divorced, and can have children.
- Contestants will show in formal gowns only. Keep in mind if are the Ms/Mrs Estill County Fair winner, KAFHS State competition requires clothing to be modest, meaning no cut outs in the attire, very modest cleavage showing, no slits will be allowed higher than mid-thigh, and no seethrough attire.
- 4. If for any reason the winner cannot fulfill her obligations as Ms/Mrs Estill County Fair, the 1st Runner Up will preside.
- 5. The Estill County Fair Board and/or Pageant Committee are not to be held responsible for any disqualifications. Grounds for disqualification can be BUT are not limited to untrue statements or registration forms, misconduct, obscene, foul language, unruly/unbecoming behavior that on
