## FROM WHAT IS BEING PROPOSED

**1.3 MILLION SQ/FT | 24 HR/7 DAY A WEEK** Distribution Facility planned on County Hwy 5 with the multiple and frequent heavy truck traffic on Hwy 5 (Beverly St.)

### COUNTY AND VILLAGE IMPACTS:

#### Traffic Congestion

- St. George (and surrounding communities) do not have the infrastructure to support constant heavy tractor-trailer traffic
- The facility includes: over 300 trailer loading docks, 300 more spaces for trailer overflow, +plus car parking
- NO direct access to major highways:
  - Only Brant County Hwy 5 to Provincial Hwy 24 | Hwy 6/8 to get to Hwy(s) 401, 403 or QEW

#### Safety for the community and impact on local businesses

- Heavy transport activity travelling directly through the downtown core (including school zones)
- Increased risk to children walking to/from German Public School and Village Daycare
- Negative impact on grocery stores, restaurants, gift shops, tourism, and community events

#### Environmental Impact

- Increased AIR, NOISE, and LIGHT Pollution all day and night... (24/7)
- Contamination to Fairchild creek south side of HWY 5
