Remember, as a garden member there is a commitment of two hours per month towards club functions and garden improvements. Be sure to sign your name in the volunteer book located in the small tool shed or the greenhouse.

Noncompliance will lead to forfeiture of membership without reimbursement. Below is a list of responsibilities around the garden. * In lieu of noncommitment of your two mandatory hours per month, you will be charged \$20 per month. You may only opt out of your volunteer obligations twice.

- *Check out the whiteboard in the tool shed.
- *Tend to absentee beds.
- *Weed Pollinator, Butterfly, and Food Forest Garden.
- *Weed around the OOCG sign at the front entrance.
- *Weed, and sweep walkway.
- *Sweep out and organize tool shed, and greenhouse
- *Bring in cardboard without tape.
- *Turn the compost (all three bins).
- *Fill garbage can next to compost bin with dry leaves found in the parking lot.
- *Stock, and organize "The Little Library ".
- *Attend Board Meetings.
- *Donate items to garden that have been approved by the BOD.
- *Plan a plant sale, garden demonstration, potluck, art class, cooking demonstration, or fundraiser.

Rules and Guidelines for The Oldsmar Organic Community Garden

Overview:

A community garden can build and strengthen the community, provide economic benefits, educate, increase social equity and promote environmental stewardship. The primary goal of these rules and regulations is to ensure an enjoyable experience for all. By signing the OOCG plot membership document, you agree to abide by the rules and guidelines outlined below.

Garden Hours: 8AM - 7PM

Upon completion of obtaining a City of Oldsmar Recreation card, orientation, payment for bed(s), and understanding the rules, members will be given the combination to the gates, and members toolshed.

Raised Bed Rental Fees:

- 1. Yearly rentals will commence on September 1st of each year. \$60-\$100 per bed must be received from returning gardeners prior to September 1st in order to retain your plot. New gardeners will be assigned beds on a first come, first serve basis.
- 2. If renewal fee is past due by 30 days, the use of the plot(s) will be forfeited.
- 3. The fee is non-refundable.
- 4. Oldsmar residence and those employed by a business residing in Oldsmar will have priority when new beds become available.
- 5. A raised bed may be transferred to a family member or friend in writing, one time, only if the original member contacts the Board of Directors in writing for confirmation and written approval acknowledging the transfer. Upon approval, the transferred member must fill out all membership paperwork and abide by the rules, and regulations.
- 6. Members may rent a maximum of 2 beds when available.

Use of own Plot:

Gardeners may use only the plots assigned to them. Gardeners must maintain their plants within their plot and will trim any plants that extend into neighboring plots or into common areas. Gardeners may not alter the dimensions of their plot. Excessively tall plants that will unduly shade adjacent plots will be prohibited. Gardeners will maintain their plots and adjacent path in a clean and neat fashion, promptly removing any weeds, overgrowth, or other waste from their plot. Gardeners will promptly harvest edible plants, and are responsible for hauling and disposing of their own trash, weeds, boxes, trays, bags, packets, and similar items.

Plantings:

Gardeners may plant vegetables, fruits, and flowers. Florida is divided into USDA zones 8 through 10. Oldsmar, Florida is in USDA Hardiness Zones 9B (Central Florida climate zone). A planting guide is available through https://sfyl.ifas.ufl.edu/lawn-and-garden/florida-gardening-calendar/, or you may see the referenced copy in the shed. There are many sources for organic and non-GMO (Genetically Modified Organism) seeds. You can find them at Lowe's, Home Depot, Ace Hardware, Whole Foods, Earth Origins Market, Shells, and by mail order (Baker Creek Heirloom Seeds, among others). Organic starts can be purchased from Wilcox Nursery in Largo or Sweetwater Organic Community Farm in Tampa.

2. Initial___

Organic methods:

Gardeners will garden organically. All soils, fertilizers, pesticides, and herbicides must be OMRI (Organic Materials Review Institute) approved. Use of compost, organic mulch, and biodigester fertilizer is acceptable. The use of organic seeds and starts is recommended whenever possible. Use the best quality ingredients you can afford. If you are in doubt about a product, please ask a board member. Gardeners may not grow any plants above 4 feet in height. Planting structures that impede the security of the garden or impede adjacent gardener's access to sunlight by the nature of their height, material, or density are prohibited.

Composting:

Each and every gardener will be responsible for composting the right way! When standards are followed, the compost can be turned around within a 6-9-week period for use in the gardens. The smaller the materials placed in the compost, the faster it will decompose. Chop it up, turn it into the existing compost, and cover it! The list of materials needed are listed above the compost bin. Items like corn cobs, melon rinds, stalks from cabbage, broccoli, and cauliflower need to be chopped up or they will take forever to break down. Please, no tomatoes, or tomato vines. No pea, or bean vines (leaves only). No roots, and no diseased plants or plants that have gone to seed.

Prohibited plants and other items:

Plants that are regulated or prohibited by federal or state laws are prohibited in the OOCG. Trees, shrubs, mint, catnip, raspberries, marijuana, and other invasive plants are prohibited in the raised garden bed.

Common Responsibilities and Volunteer Commitment:

All members are responsible for the overall appearance of the Community Garden. A list of tasks can be found inside the volunteer log books, the whiteboard located inside of the tool room, and our website <u>oocg.org</u> under Rules and Regulations. As a member of the garden, there is a commitment to contribute <u>2 volunteer hours per month</u> towards club functions or garden improvements. Log books for documenting volunteer times are available inside the tool room or the greenhouse. Members are restricted from opting out of volunteering no more than two times within a 12 month period, at which time will be charged \$20 per month for non-compliance. Non-compliance will lead to forfeiture of membership without reimbursement.

Absence: Members may not abandon their plot(s). Abandonment means failing to maintain a plot for 2 or more weeks. If a member expects to be away from the garden for more than 2 weeks, but less than 2 months he or she must inform the Board of Directors (oldsmarorganicgarden@gmail.com). Members who are away for more than 2 months without communicating to the Board of Directors will lose their plot(s). Terminated members are not entitled to any refunds or other payments from the community garden.

Water Conservation Rules

The irrigation system will operate 7days a week from 5am until 6am. Individual gardens requiring additional water may only be hand watered, using the sprinkler cans located beside each rain barrel, before 10am, and after 5pm. In most instances, it is unnecessary to use additional water unless you are planting new seedlings or starter plants in your garden. Too much water can rot the roots and rob the plants of much needed air. Soil that is constantly wet will also cause diseases and unwanted pests. If the soil has dried to a depth of 3 - 4", the garden needs water. (For your convenience, water gauges are located inside of the toolshed.)

<u>Build your soil:</u> Adding organic amendments will help your soil retain moisture and provide nutrition to the plants. Adding **2** - **3**" of compost material, found in the **3**rd finished compost bin, can greatly reduce water use and add needed nutrients to the soil.

<u>Plant wisely:</u> Florida is in USDA Hardiness Zone 9B. A planting guide is available through https://sfyl.ifas.ufl.edu/lawn-and-garden/floridagardenipg-calendar/ or you may read the referenced guidelines found in the greenhouse, and the toolshed.

Due to the cost and effectiveness of watering, all gardeners are prohibited from watering (to include the transfer of new seedlings and plants) between the hours of loam til 5pm. 60% of moisture is lost during watering when the soil is hot. Excessive watering is unnecessary.

Children should be supervised by an adult at all times around all water outlets. By modeling appropriate behavior when assisting your children to plant, water, and respect the rules of the garden is a responsibility that promotes a childs sense of accomplishment and accountability.

Tampering with the irrigation timer at any time is prohibited.	Initial

Common Tools:

Tools and sprays in the garden storage shed are shared by all members. Please return after using. All tools and lawn equipment are the property of the OOCG and are not to leave the garden premises. Trellises, stakes, and some fencing are found behind the large shed for members to use. Do not store your personal tools, sprays or trellises inside or behind the garden shed unless you are contributing them to the garden collection to be shared by all gardeners.

Respect Others Property:

Members and guests may not enter other members plots, use another members tools or supplies, or harvest another gardener's produce, without the explicit permission of the other gardener.

Guests:

Members may bring guests, including children, into the garden, provided that the guest(s) complies with the rules. Members will supervise any child under the age of 16. Members will be responsible for the conduct of the children and their guest(s) making sure they do not damage or interfere with activities on other plots or engage in inappropriate conduct.

General Conduct:

Members are expected to be civil, honest, and cooperative in dealing with other gardeners, and their guests to include:

- **❖ No Smoking**
- ❖ No Alcohol or Drug use
- ❖ No Open Fires
- ❖ No Soliciting
- No Loud Music. Bring your ear buds to listen to your favorite music.
- Do not Molest, (bother) Feed or Remove any Wildlife from the garden, other than the Insects that are causing harm, and invading your produce.
