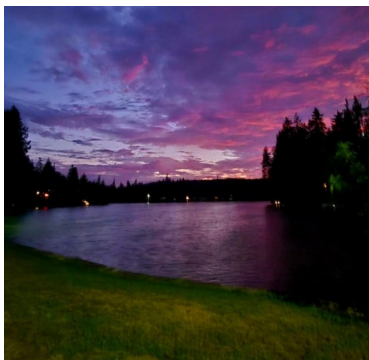

MESSAGES FROM OUR BOARD OF TRUSTEES

TREASURER

- The Board is beginning to work on the budget for 2026. Initial Budget numbers should be consolidated no later than early September with a copy going to the community shortly after. The current goal is to have the Board vote to approve the budget at the September Board Meeting 9/15/2025. Once you receive your 2026 Budget copy, please address any concerns to the FLMC Office where they will be forwarded to the correct party.
- The past treasurer had committed to limiting the assessments increase for 2026, to \$50. This is barring any unforeseen circumstances or budget line items that may be required for 2026. This is in accordance with bylaw recommendations. This increase is not designed to cover 100% of expected needs.

- ♦ With Tracy at the helm, the ship is moving forward. Not to say we won't have a bit of choppy water, but overall there is light at the end of the tunnel. Bill Knight—Water Systems

The booster pumps are well beyond their life cycle and need to be replaced. Their purpose is to boost or increase the water pressure to the approximately sixty residents at the higher elevation of our community. The Board received and reviewed bids from three contractors for the replacement of the booster pumps. The decision was made to award the project to Stirrett Johnsen which met our specifications and was the lowest cost bid submitted. The equipment has been ordered and could take 4 to 6 weeks to arrive. The work will be completed in one day and Residents will be given advanced notice before the work begins.

The Board has decided to postpone til 2026 replacing more of the AC water pipe. This decision was so FLMC could potentially take advantage of a PUD contribution for excavation.

AC Pipe Replacement

The Board agreed to postpone this year's project, the replacement of the AC pipe along Crescent from the dam to Foxglove TIL 2026. More information is needed to determine the best approach to excavating the pipeline that will minimize disruption to residents property and the most cost effective method. In addition, the participation of PUD3 in sharing the excavation and restoration costs needs to be determined which would add considerable savings to FLMC for this project.

Cross Connection Survey

As per the Washington Department of Health WAC #246-290-490 all community water systems shall comply with the cross-connection control requirements. The purpose of a cross-connection control program is to protect our water system from contamination and prevent the undesirable reversal of the flow of water or other substances through a cross-connection into the Fawn Lake water system. A short survey will be sent to all residents regarding the water system connection at your residence that might potentially be a hazard to our water system. Please take the time to complete the survey and return to the office. **THIS IS MANDATORY, SO PLEASE COMPLETE!**
