While I know it was a bit bumpy at the beginning, I think the team outdid itself with the equipment we have on-hand. Unlike many cities that are in the snow belt preparation for a storm can be challenging for those who are not. Bill Knight: Water

• With the freezing cold nights and slightly warmer days its important to keep an eye on your water pipes. We often see frozen pipes reveal themselves during the warmer parts of the day when the water in the line thaws. Watch and listen—you may hear water running when no faucet is on (both inside and outside of the home) or see pooling of water in your yard. Please keep an eye and ear out on behalf of your neighbors who don't live here full time. Leaking pipes can create major water damage in a short time.

Steve Jacobson: Treasurer

- The Financial Committee met for the second time on Thursday, February 20th. During that hour and twenty minute meeting, we covered the year-end financial reports and the Reserve Study Executive Summary. We will share by email next month the year-to-date numbers, and will meet again just before the April General meeting.
- Did you know that you can pay your assessment electronically? You can either pay by ACH/Echeck or credit card. The credit card charge is 2.75%, no charge on ACH/Echeck. You can also make monthly payments if need be.
- We are now moving money to Morgan Stanley as you pay your assessments. We hope to gain more interest income.

INTRODUCING THE FAWN LAKE FINANCIAL COMMITTEE

The financial portion of Fawn Lake has the responsibility of a number of actions. These actions are directed by the Treasurer, who is an Executive Member of the Board. There is also a Bookkeeper, who keeps the accounts for tracking and reporting purposes. We now have a group of community members who comprise the Financial Committee.

The Treasurer is responsible for seeing that financial reports are published monthly, a "State of the Commission" is given at General Meetings, the Reserve Study is completed and used, taxes filed, audits completed, and monies invested in safe income vehicles.

Working closely with Tracy Winston, our bookkeeper, we came into our positions about two years ago. In that amount of time we have straightened out our bill paying, accounts used to handle those expenses and income. We have separated Reserve Funds from Operating Funds, invested the funds so that we generated \$62,000 in interest last year, \$22,000 the prior year. The year before there was less than \$1,000 income.

After Tracy cleaned up the books, we then filed 5 years of back taxes that had not been filed. We completed the first audit done in 6 years. We also had a member of our Financial Committee help us do an internal audit.

We have changed how we handle funds from depositing all funds in checking, which generated zero income, to a money market account. We also opened an account with Morgan Stanley to hold our Reserve Funds. We now have opened another high yield savings account to hold our funds during the year.

We have set up a process that includes two Board Members who do all of the fund transfers, supervised by the Treasurer and Bookkeeper. We have 3 Board Members authorized to sign checks. None of these duties are allowed to be performed by the Treasurer.

Heather Tremblay: Gate

- ◆ CERT Training: Are you ready to respond if disaster strikes? This FREE training from the Dept. of Disaster Management takes place in May 2025 and is for all ages and activity levels—anyone can participate. See the training flyer on page 4.
- EXIT GATE ALERT: Our gate area speed limit is 5mph. After multiple efforts to slow gate traffic, ongoing damage from vehicles speeding over the exit spikes requires further action. Please encourage your neighbors to slow down. We will begin trials on alternatives for our exit, including operating the iron exit swing gate full-time. Watch your E-Service and the reader board for exit gate updates.
- ♦ 4-DIGIT CODES: We are updating all 4-digit codes (used for medical and vendors) to reduce accidental calls to residents from the gate. We will be sending out a letter to those who currently have a 4-digit code in the upcoming weeks that requires your response, to ensure your 4-digit code remains active.
