

Cross Connection Survey

As per the Washington Department of Health WAC #246-290-490 all community water systems shall comply with the cross-connection control requirements. The purpose of a cross-connection control program is to protect our water system from contamination and prevent the undesirable reversal of the flow of water or other substances through a cross-connection into the Fawn Lake water system. A short survey will be sent to all residents regarding the water system connection at your resident that might potentially be a hazard to our water system. Please take the time to complete the survey and return to the office at your earliest convenience.

FLMC Water Master Position Open

After serving as our Water Master here at Fawn Lake for over forty years, Tom Moore will be retiring the end of this year. We will begin advertising and recruiting for his replacement. Perhaps some of our residents know of someone that would be interested in this part time position. The position requires certification as a Water Distribution Manager 1 (WDM1), Water Treatment Plant Operator (WTPO1) and a Cross-Connection Control Specialist 1 (CCS1) or the ability to obtain a CCS 1 within one year of employment. Relocation of Boats for Winter-Lake & Dam Trustee

Several boats stored at all parks appear to be abandoned, damaged, or not In use. This leads to an unorganized, poor appearance in areas visible to the public

Community residents that have boats stored at any of the parks need to remove and re-located the no later than Oct 31, 2025. All boats left in a Fawn Lake park after that date will be removed and disposed of by FLMC.

Between Nov 1, 2025, through March 31, 2026, the board will review the parks and identify and/or implement areas that be designated boat areas. Boats will then only be allowed to be stored from Mar 31 to October 31 each year in those designated parks/area's.


