FAWN LAKE NEWS AND VIEWS May 2025

Spring 2025 Annual General Meeting

FLMC held its Spring General Meeting on Saturday, April 26th at Mason PUD 3. At the meeting, Trustees presented department reports; upcoming community activities were announced; and calls for nominations for the Hearing & Ethics Committee and for open Trustee positions were announced.

News shared at the meeting included the resignation of Matt Matincheck from the Board. We thank Matt for his tireless commitment to the health of the lake and his desire to build a healthy fishery for residents to enjoy. We wish Matt the best in the future and are grateful that he will be continuing behind the scenes providing valuable insight to the Lake & Dam department.

With the resignation of Matt, the Board has approved the nomination of Brad Pense to the Board to fill out the remainder of Matt's term. Brad was introduced at the meeting and will be covering Lake & Dam. Brad brings the previous experience he gained while supporting Matt in this role.

For Hearing & Ethics, Jan Charles and Ellen Levack have both been nominated to continue to serve on the committee. Bill Kysor was also nominated to serve. All have accepted their nominations. Since there was not more nominations than open positions, an election will not be required. Nat Johnston and Kristen Boyle have resigned from H& E and we thank them for their time and their commitment to the community.

For Trustee positions, Heather Tremblay, Bill Knight and Teresa Becker were all nominated to continue to serve, as their terms expire in June 2025. All have accepted their nominations. Since there was not more nominations than open Trustee positions, an election will not be required.

Chris Clifford joined the Board June 2024 to cover an unfilled position which has a term ending in June 2026. Chris has agreed to continue to serve, covering Septic and Buildings. The Board moved, seconded and passed to confirm Chris to the Board for the remainder of the term.

The meeting ended with an Open Discussion Forum where attendees asked questions, expressed concerns and compliments and made general announcements for the good of the order. The Trustees appreciate and value the input.

Thank you to everyone who attended the meeting. A huge shout out to those who helped set up, tear down, sign in, made goodies, etc. We can't do it without your help!

MESSAGES FROM OUR BOARD OF TRUSTEES

Steve Jacobson: Treasurer

- Finance Committee Volunteers wanted. A willingness to learn about our FL financials is all that's required for participation on this board committee. If your schedule allows for meetings every other month for about 90 minutes, please contact me at treasurer@fawnlakecommunity.com to sign up.
- Updated Reserve Study has been received and was shared at the Spring General Meeting, as well as, emailed to members. It is also available on the website.
- THE PLAN: We are stretching the AC Pipe replacement into 5 sections, replacing a section every other year; this will take 10 years. The plan assumes ALL pipe (including aging PVC pipe) will be replaced on an every-other-year schedule, which will take 40 years.

Teresa Becker: Parks, Grounds & Roads

- Please report standing water in ditches and culverts, as this affects the longevity of the road. If you are doing maintenance in culverts, let us know. The ditches and culverts are supposed to have grass/small vegetation in them which helps to absorb water, helping to keep it from seeping under the asphalt and undermining the road foundation.
- Working with Everson Asphalt to plan 2025 road projects. The initial bid was greater than the 2025 budget, so we will be focusing on a few really bad spots for this year.
- Please use caution while on the dock at Hawthorne Park. We are currently looking at options for the railing.

Bill Knight: Water

- With monthly meter reading, we are able to identify high water use sooner. If you are sent a water
 overuse warning letter, please take it seriously and try to determine the cause of the over use. It
 could be a leak or simply extra activities within your home that caused the increase. Leaks need to
 be repaired immediately!
- Water Restrictions begin now. We are expected to have another unusually dry and hot summer, so water conservation is important to start now. Even-numbered properties can water on even-numbered days. Odd-numbered properties can water on odd days. This applies to automatic sprinkler systems, too, so be sure to reset your timers.
- Cross-connection survey will be coming out soon. This is a mandatory component of small water
 systems and we need ALL HOUSEHOLDS to complete and return the survey. More information
 about how and why to complete the form will be included. Please help us by making it a priority to
 participate in this important process for protecting the safety of our drinking water.
- Planning continues on the booster pump replacement and AC pipe replacement.
- Water towers are due for inspection and cleaning. We will be having the walls cleaned, as well as, the floors, since it has been a while since the walls were cleaned and inspected.

Debra Deir: Vice President-covering Bylaws

- We continue to work with a few properties around the community to get them cleaned up.
- We will begin focusing on properties for tall grass, brush, etc. prior to the 4th of July. Please make plans to make and keep your property free of flammable debris, etc. It appears we are in for a long hot and dry summer.
- I encourage residents to continue to use the online submission form for alleged bylaw violations.

Chris Clifford: Septic Systems, Buildings

- Last filter cleaning of lots on the LOSS showed north-side properties were significantly dirtier than normal and dirtier than south-side properties, which historically have been dirtier.
- Continuing to monitor the "sink hole" on the tracks and communicating with the railroad.

Heather Tremblay: Community Liaison and Gate

- Exit gate repairs are in process. Excess speeds above 5pmh in the gate area are a gate violation and will be fined accordingly. Please enter and exit with care to keep our community safe.
- Swing gate survey shows the majority of the community prefers the exit swing gate to be operational 24/7. Proposing that we use both entry and exit swing gates 24/7, with these exceptions: entry gate held open 3-7pm and exit gate held open 5:30-9:30am. Comments? Email me at gate@fawnlakecommunity.com. The Board will make a decision in May.


