In accordance with Fawn Lake By-laws, Chapter 14, Sec.2:

"Building permits, restrictions and limitations: Written notification of intent to excavate or construct either permanent or temporary buildings, outbuildings, sewage disposal systems, docks or placing trailers or mobile homes on any lot shall be submitted for consent by the Fawn Lake Maintenance Commission Building Committee prior to commencement of such action. Only members in good standing who have paid in full all dues, fines and fees may be issued a building permit."

Violation of this Subsection constitutes a Class II violation as covered in Chapter 13 Section 5 (B).

- **Please provide a definitive house plan** and/or diagram which shows proposed construction site in direct relation to layout of property; also include applicable footage from property boundaries, easements, and setbacks.
- **The Fawn Lake Building Liaison shall have the right to observe on-site construction** and to require correction of significant deficiencies with reference to Mason County construction codes. Visit www.co.mason.wa.us for information on Mason County permits, codes, and regulations.
- **All setback and easements** shall be in accordance with established Mason County regulations.
- **Mason County permit requirements for water use, septic, and construction** must be obtained as necessary.
- **You must provide height footage with this construction application and** be in compliance with Fawn Lake building height restrictions. For height specs, please refer to Fawn Lake By-Laws, Chapter 14, Sec. 2D.
