Buildings and Permits

Parks, Grounds and Roads

• Vandalism at Cabana and multiple road signs "tagged" or dented. Cameras at Cabana are not sufficient to see who comes and goes in restrooms. 2023 budget not sufficient to cover cost to clean/paint over.

Water Systems Bill Knight

- Software and meters are ready for radio reads. Took about 1 hour for the first read. Still working with the vendor to work out some bugs. Working toward monthly readings.
- AC Pipe replacement Dan Lovell writing up scope of work for replacement at end of lake by dam.
- Tree removal approximately 86 trees planted in easement that may affect water main. 26 trees on Alpine Ave of greatest concern. 3 bids for removal were received. Lowest bid not available until August.

Septic Systems Curt Pense

• Sent out request for bids for pumping the LOSS and providing discounted pumping to other members of the community who need their septic pumped and / or inspected.

Lake and Dam Matt Matincheck

- Leaks in concrete, will have someone come inspect and repair.
- Asian Grass Carp is a "no go". State found bass and perch in Lynch Creek; believe came from Fawn Lake, so state will not approve permit for carp.
- Yellow Flag Iris is a noxious weed and needs to come out. Spraying of cattails and lily pads coming soon; uses
 the same chemical for the iris. Not all cattails will be
 removed.

Trustee at Large Mike Ricchio

• Nondisclosure Agreements need to be signed by all Trustees, employees and volunteers. A reminder to all about protecting private information you may be aware of.
