## **MESSAGES FROM OUR BOARD OF TRUSTEES**

## Steve Jacobson: Treasurer

- The Board has moved to move any funding from the checking account to the Morgan Stanley reserve funds in excess of \$140,000.
- We are realigning how money is handled, with additional security being used.
- We came in under operating budget for 2023, with increased spending in Capital Expenses.

### Steve Jacobson: Roads

- Road work has concluded for the year
- We are in the process of making an offer for a new Maintenance Technician to replace Don Williams, who has retired as of December 31st.

## Bill Knight: Water

- AC Pipe Replacement—Last month they started excavation and water valve replacement on Crescent by the dam and spillway at the east end of the lake. It turns out that the configurations, size and structure of the water lines were not as expected according to our maps. As a result, we need to redesign and make adjustments to the project. Work will start again the middle of this month and we will notify all residents affected by any water shutdowns necessary for completion of the work.
- Firewood Access to Residents—With the holidays and busy schedules we decided to postpone the access of our residents to the trees stored at the water towers until the end of this month. We have a lot of residents interested and we are trying to develop a schedule for cutting that is fair and equitable to al participants. Something will be forthcoming in the next few weeks to allow access to the trees for cutting firewood.
- 811 Water Line Location Services—When you call 811 to request locations services, our Water Technicians receive these requests directly. Please note, that FLMC is only responsible for locating the water line from the street to your water meter. The resident is responsible for the water line from the water meter to their home. The PVC water lines to your home are nonmetallic and therefore undetectable. In this situation, you must use ground penetrating radar (GPR) to locate the water line. We do not have this instrument at FLMC because they cost anywhere from \$50,000 to \$70,000. There are contractors that you can hire to locate your water lines with GPR. There is a practical alternative using visible water facilities such as water meters, water valve covers and junction boxes. If you draw an imaginary line between your meter and neighbor's meter and don't dig/trench between that imaginary line, there should be no risk to the community water mains. Should you find the need to dig within the space where our water mains are, be aware that we believe they are at a depth of 12-24 inches. Also, they have been in the ground for over 50 years, so should be presumed to be brittle and fragile. If you find that you will be digging near the main, we encourage all digging to be done by hand to mitigate any chance of breaking the main water line. Please be advised that if the water main is damaged, the residents will be responsible for all expenses associated with the repair by FLMC.

Outdoor burning is allowed at this time of year but no burning of rubbish or garbage and burn barrels are illegal for any form of outdoor burning. The fire must not create a nuisance from smoke, obscure visibility on roads or endanger life or property. Recreational fires must be in a metal or concrete fire pit and are limited to a maximum of 3 feet in diameter. Remember, when it comes to recreational fires—size matters!
