All Members are invited to attend the Fawn Lake Maintenance Commission (FLMC) October Semi-Annual General Meeting (S-AGM) to be held on Saturday, October 28, 2023 at 9 am. Sign in and social time will be from 8:30 to 9:00 am.

During the meeting there will be presentations from the FLMC Board of Trustees as well as a call from the floor for nominations for those interested in joining the Board. Board sign-up sheets will be made available at the S-AGM. Currently we have 2 mid-term vacancies. Executive positions for President and Vice-President will be decided by the seated board in November 2023.

Following each presentation there will be a 5 minute moderated question period for the presenting Board Member.

The Board of Trustees, during the Board Meeting September 21, 2023, approved the FLMC 2024 Annual Budget for General Assessments (Operational and Reserve) and that the Annual Assessment be \$1200 for each member property in FLMC. During the meeting all the FLMC Members, in good standing, will be issued a ballot to vote to ratify the budget. Votes will be distributed during sign-in at the meeting.

Proxy forms for the meeting will be made available on our website under News & Forms or in the FLMC office starting October 2, 2023. Proxies may only be assigned to a FLMC Member or a Trustee of the FLMC Board. Please note, both members assigning their proxy and the receiving members must be in good standing to vote.

On or before October 6, 2023, a mailer will be sent out, via First Class USPS, to the address of record at FLMC notifying you of the S-AGM meeting date, time and location along with applicable budget handouts as outline in RCW 64.90.525. Should you not receive your packet in a timely manner, please notify the office at fawnlakeoffice@gmail.com.

Should a member in good standing wish to be recognized to speak under New Business at the meeting, for a maximum of 5 minutes per member, please complete a Request to Address the S-AGM form, available online or in the office starting October 2, 2023.

During the meeting, we will also be looking to sign up FLMC Members to our Community E-Service email. The email service is designed to keep you notified of important happenings, good or bad, as well as Community Events in Fawn Lake. Participation in E-Service requires you to complete a signed Authorization Form. Your information will not be used for any marketing purposes and is used only by Fawn Lake. Be a part of our FLMC Community in the know! Form is also available on our website or in the office during Member Hours.

Look forward to seeing you all at the Semi-Annual General Meeting on the 28th.

MESSAGES FROM OUR BOARD OF TRUSTEES

Steve Jacobson: Treasurer

The Board at the September meeting passed the 2024 budget and assessment:

2024 Operating Expense Budget \$350,000 2024 Reserve Funding \$300,000 Less 2024 Budgeted Misc. Income Net amount needed to fund both Assessment per property for 2024 \$1,200

Also approved expenditures from Reserve Study recommendations: water system booster station, well #2 pump, new computer for reading meters, update of Water System Plan, repaint buildings exterior, pot hole repair. Approximate cost \$195,000.

Reserve Study estimates that we are 16.9% funded for assets that have been used, which is up from 14.8% a year ago.

This year the ratification process will take place at the October General Meeting. All owners who are in good standing will be able to vote for/against at that time. If you are not able to attend the meeting, you will be able to access a proxy form from our web site, or by stopping by the office to pick one up. You are eligible for one vote (proxy) per property in good standing.

Bill Knight: Water

<u>AC Water Line Replacement</u>—A request for proposal (RFP) has been sent to six contractors for the replacement of the asbestos concrete water main located on the East end of the lake along the dam. There was a mandatory pre-bid meeting on-site for the contractors on 9/29. Written proposals will be due on October 12th to be reviewed by the Board. Once the award has been made and the work scheduled, the residents affected by the construction will be given plenty of advanced notice.

<u>Tree Removal along Alpine</u>—27 large trees were removed along Alpine because their roots were a threat to damaging the asbestos concrete water line. The trees have been moved next to the water towers and will be made available to all residents interested in cutting them up for firewood. However, the Board is concerned about the Community's liability if someone was hurt while cutting the trees on Fawn Lake property. We are seeking legal advice in this regard and will let everyone know when residents can access the wood.

<u>Water Conservation during a power outage</u>—As Winter approaches and the risk of a power outage increases, it is important to know that water conservation during a power outage is critical. Our water system pumps are operated by electricity from PUD. We do not have a backup generator. So, when we lose power our water pumps stop working but our water towers are still full of water. During a power outage you will still receive water due to the gravity feed from the water towers. It will most likely last for only a few days until the water tanks empty. This is the time to conserve water so that our water supply will last longer until the power is restored.

Heather Tremblay: Gate & Community Liaison

CodeRED is a new tool that will ensure you hear the latest updates from police, fire and other first responders that may affect our area. When you sign up for CodeRED, you may enter landline and/or cellular phones, email(s) and your address to be used in notification of emergencies, alerts and updates regarding our county and specific areas. Fawn Lake has been added as a notification group. Tell your neighbors about CodeRED and contact Mason County Emergency Services with questions about this new tool at 360-425-9670. See instructions for signing up for CodeRED at the end of the newsletter.

Unmarked boats have been moved to the water towers. Owners can claim until October 31st. Unclaimed vessels will be offered for auction after November 1st.

Did you know....?

By-Laws section 14.4.N.4 states "When an RV is not being actively used, all personal property shall be kept within the RV or in a storage unit. If an RV is to be covered, the Member shall use a cover specifically designed for this purpose"

This means that any property that is a vacant lot and/ or has an RV on it, needs to have everything be put away inside the RV or shed when you are not actively enjoying Fawn Lake. This would include, but not limited to lawnmowers, bar-b-ques-, chairs, tables, bicycles, toys, etc.

Keeping personal items stored and out of sight while you are away will help to deter would-be thieves, not to mention increasing the useful life of the item by not having it constantly exposed to the weather.


CodeRED Sign Up Instructions

To sign up follow the instructions below:

- 1) Open your web browser and go to https://masoncountywa.gov/index.php
- 2) Scroll down on the Home Page, viewing the lefthand side blue bar to "ONLINE SERVICES" and select Emergency Alert Notification Signup (pictured below)



- 3) Create a new account, entering a username and password.
- Continue to enter your address and notification phone and/or email for both general and emergency alerts.
- 5) Select your notification areas: Arcadia/Kamilche and Fawn Lake would cover your home area.
