FAWN LAKE COMMUNITY NEWS
JANUARY 2026



2025 has been a year of implementation. We are at the pint as a community where we are now investing in infrastructure issues. Some of the projects that were accomplished were additional road repairs, replacement of the booster pumps on the water system (less electricity use, replacement of obsolete equipment), added an additional valve to the dam outflow (safety), added hvac and new windows in the office (less electricity), improved lake treatment, gate worked well for most of the year, replaced old, broken fencing around the swim area.

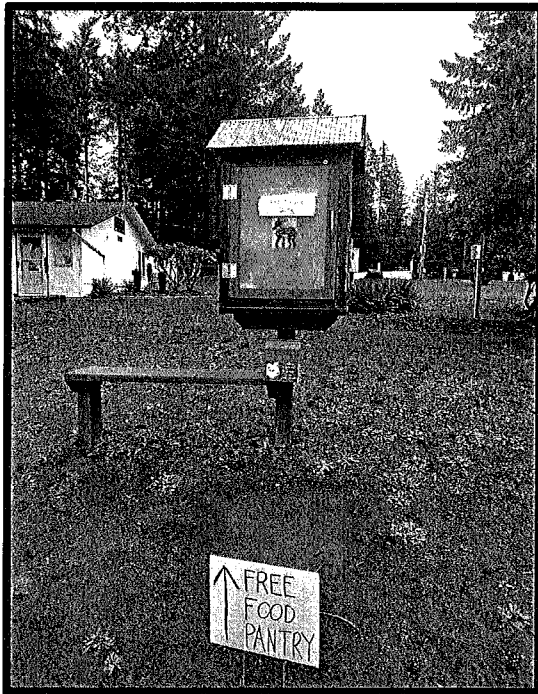
2025 found instances where community volunteers donated money for improvements. One was buying new tables for the cabana, which are a major upgrade over the old wood tables. Another donation paid for improvements to the front of Bryant Hall, another esthetic improvement.

2025 also had some major challenges, as we have been and continue to be engaged in legal issues concerning properties at the lake. We also ran into weather related issues affecting the condition of the lake. Both of these issues have spurred the Board into additional steps to address the conditions.

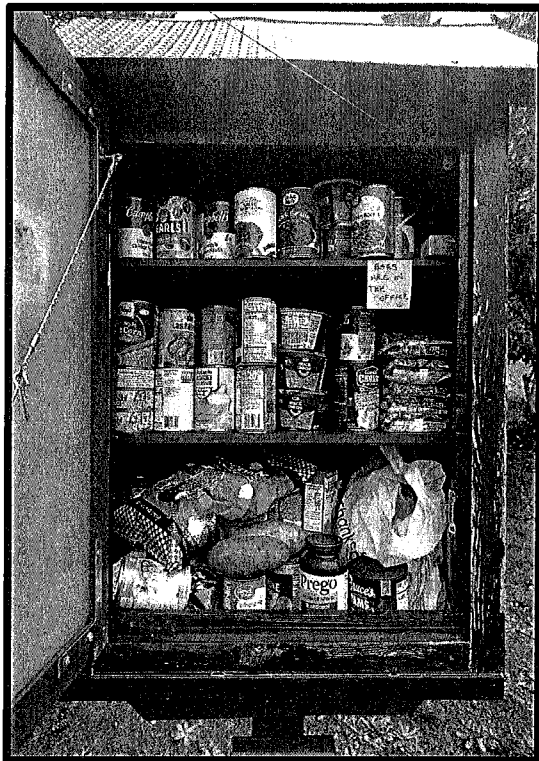
2026 will be a year of major investments in infrastructure. We plan on replacing part of the main pipeline this year, which will run \$400,000 (approximate). In total, we may spend up to \$580,000 total.

The Board now has 10 members, some have been on the Board for a while, some new. We will be spending time on developing high performance team efforts.

Cross Connection Survey

As per the Washington Department of Health WAC #246-290-490 all community water systems shall comply with the cross-connection requirements. The purpose of a cross-connection control program is to protect our water system from contamination and prevent the undesirable reversal of the flow of water or other substances through a cross-connection into the Fawn Lake water system. A short survey was sent to all residents regarding the water system connection at your residence that might potentially be a hazard to our water system. Please take the time to complete the survey and return to the office at your earliest convenience. If you haven't received one in the mail or via email, please contact the office for a replacement.

Working together we will continue to enjoy a safe, secure community. Consider joining Neighborhood Watch by emailing fawnlakew@gmail.com to stay involved and aware.


