Fall Semi-Annual General Meeting

Saturday, October 26th, 9am Johns Prairie Room, PUD 3 2621 E Johns Prairie Rd

Sign in and social time starts at 8:30am. Meeting starts promptly at 9am.

During the meeting there will be presentations from the FLMC Board of Trustees, a vote for Budget Ratification (open to Members in Good Standing), and a call from the floor for nominations for those interested in joining the Board. Currently, we have 2 mid-term vacancies. Proxy forms will be available online and in the office.

After the Business Meeting, we will have a 30-minute moderated Town Hall where Members will be able to ask questions of the Board Members.

2025 BUDGET AND ANNUAL ASSESSMENT

The Board has voted for the 2025 Operating Budget, the Capital Expense Budget and the 2025 Annual Assessment. The Operating Budget for 2025 is \$350,000. The Annual Assessment per property is \$1,400 for 2025.

As per state law, the community does have a say in this process. At the October 26th Fall Semi-Annual General Meeting ballots will be provided for those community members in good standing who wish to express their opinion on the budget and assessment. If you cannot attend, you may have your proxy presented at the meeting by a member in good standing that you assign your vote. More details will be sent via USPS or email, based on your communication preference. A reminder: 50% + 1 of the community members in good standing would have to vote "no" for the Board's decision to be overturned.

MESSAGES FROM OUR BOARD OF TRUSTEES

Steve Jacobson: Treasurer

- The Board has approved the Operating Budget for 2025. The expense portion will be \$350,000. This money is used for the day to day operating expense of the community. In addition, the Board has tentatively approved \$400,000 in capital expense projects. These include \$300,000 for AC Pipe replacement (20% of the approximate total), \$10,000 for Water System Plan update, \$17,000 for water tank repair and cleaning, \$42,000 for road repair, and \$10,000 for Bryant Hall update.
- ♦ The Reserve Study calls for \$447,000 to be added to Reserve funding. Miscellaneous income is estimated to be \$71,000.
- These numbers led the Board to making the decision to increase the 2025 annual assessment to \$1,400 for the year. The assessment will be due by April 1. You may choose to pay half by April 1 and the second half by October 1.

Heather Tremblay: Gate and Community

- New Entry Swing Gate: We will be testing daytime operation of our new entry swing gate periodically through the month of October, in an attempt to reduce tailgate traffic. Watch your email and our Facebook group for updates.
- Report Gate Infractions: Tailgating causes damage to our gate and allows unwelcome visitors into our community. If you see something, say something by emailing gate@fawnlakecommunity.com. Please include style and color of car, along with date and time of the incident. Let's keep our community safe!
- Recreational Fires Allowed: Please use common sense and safety measures recommended by our Fire Marshal. Please note: land clearing and the burning of yard clippings, leaves, branches, etc. will remain prohibited until the fire danger rating drops to low. Details available at Fire Marshal-Recreational Burning (masoncountywa.gov)

TIP OF THE MONTH

FOCUSING ON THE GATE

There has been a lot of activity around the gate this summer, including the installation of the new entry swing gate. So, now is an appropriate time to go over some tips in navigating the gate system.....

Remotes are the fastest, easiest way for residents to enter the community. If you are relying on "calling your-self in", we ask that you consider purchasing a remote for access. This helps keep traffic moving through the gate. There may be nothing more annoying after a hard day's work than to sit at the gate while a resident "button pusher" waits for their cell phone to ring so they can let themselves in. Prices for remotes have dropped to \$30 each. Renters must have the landlord purchase and provide remotes. Landlords, we encourage you to provide remotes for your tenants to help reduce congestion and issues at the gate.

A tip to ensure your remote is always ready to let you in....replace the batteries when you move your clock forward or back 1 hour, just like they recommend to check your smoke alarms. Easy to remember and you will know your remote batteries are always fresh and ready to let you in the gate.

3-digit codes are used by your guests to enter the community. When the code is entered, the gate calls the programmed phone number so you can let your guests in. We ask that you do not let in people that you do not know or not expecting. You may need to hold the 9 for just a moment (think "1 Mississippi") to ensure the tone is registered by the gate. You will know when the gate has received the tone because the phone call will end. You must provide your 3-digit code when placing orders for delivery such as DoorDash, Domino's, or for services such as housekeepers, pest control, lawn/landscape service, etc.

4-digit codes are "direct entry" codes that do not require a resident to answer the phone and open the gate. These codes are only given to residents under special circumstances such as a caregiver providing service to a specific resident who is unable to answer a gate call in a timely manner; for contractors doing longer projects for residents such as new construction; or for a one-time, special event a resident may be hosting such as a family reunion. These codes must be requested by the resident and utilized only for the purpose stated in the request. Residents who are given 4-digit codes are ultimately responsible for who they share the code with and the use or misuse of the code. Misuse of the code, will result in the resident losing the privilege.

Vendors who provide service to a broad spectrum of the community each time they enter, such as the US Postal Service, Mason County Garbage, Fedex or UPS, etc, may also be assigned 4-digit codes. Each vendor must apply for a 4-digit code under their business name. Vendors are held to the same standard of not sharing the code or using it for personal access to the community. Vendors who misuse the code will have the code revoked.



Feeding Deer in Urban and Suburban Areas... Is it Harmful?



mpacts of feeding deer in urban and suburban areas

Many well-meaning Washington residents in urban and suburban areas enjoy feeding deer in their yards, especially during winter months. Although some people see this type of feeding as helping these animals, it actually can hurt them and potentially cause illness and death for the animal.

Wildlife adapt to survive winter months without our help

Many people believe that deer lack good natural food sources during winter and therefore need supplemental food to survive. However, these animals have remarkable abilities to survive winter conditions without human help, including:

- Growing insulating guard hairs and underfur
- Storing fat
- Changing their diet to fibrous, woody browse
- Migrating to areas with less snow and better feed
- Lowering their metabolic rates
- Conserving energy by restricting movements during severe weather

Keep deer wild – backyard feeding does more harm than good.

Feeding urban and suburban deer can be harmfu

Feeding wildlife can cause serious health issues for the animals and negatively effect you and your neighbors. WDFW discourages feeding deer in urban and suburban areas for several reasons:

- Deer digestive systems are well adapted to handle natural forage. Although these animals will eat feed that humans provide, carbohydrate-rich foods like fruit, grains, and corn aren't normally part of their natural diet, especially during winter, and can cause serious health problems.
- The high amount of sugars in fruit, grain, and corn rapidly ferments in the stomach, causing an over-production of acid and damage to the stomach lining. Acid and bacterial toxins can then leak into the bloodstream, causing a painful death.
- Feeding urban and suburban deer can increase negative human-wildlife interactions and result in unintended consequences for the animal and your community. Specific examples include: increased risk of vehicle collisions; increased aggression towards pets and people; increased risk of disease transmission; increased dependency on humans for food and a loss of normal, wild behavior; increased negative impacts to wildlife diversity and abundance; and increased damage to fences, gardens, and ornamental plants and trees.

Supplemental feeding may attract carnivores, such as bears, cougars, and coyotes that may prey upon wild animals using a feed site or nearby pets or farm animals. Encounters between humans and large carnivores are typically rare, but feeding deer creates the potential for unnecessary and avoidable conflict between humans and predators. This may cause a dangerous situation for people and result in an animal being euthanized.

Though WDFW may conduct large-scale deer feeding programs in certain areas, primarily in winter, these are only done under very specific conditions. For more information on these programs or to discuss deer feeding in general, please contact your local District Wildlife Biologist or Wildlife Conflict Specialist.
