# PROPOSED AMENDED AND RESTATED

# ARTICLES OF INCORPORATION OF COUNTRY CLUB PROPERTY OWNERS ASS

WILDWOOD COUNTRY CLUB PROPERTY OWNERS ASSOCIATION, INC. a Florida corporation, Not-for-Profit

[Substantial Rewording of the Articles of Incorporation. See existing Articles of Incorporation for present text.]

These are the Articles of Incorporation of WILDWOOD COUNTRY CLUB PROPERTY OWNERS ASSOCIATION, INC., a not-for-profit corporation under Chapter 617, Florida Statutes:

#### **ARTICLE 1 – NAME**

The name of the corporation shall be WILDWOOD COUNTRY CLUB PROPERTY OWNERS ASSOCIATION, INC. (hereinafter referred to as the "Association").

## ARTICLE 2 - PRINCIPAL OFFICE

The principal office of the Association shall be located at 218 County Club Drive, Crawfordville, Florida 32327. The mailing address of the Association is 218 County Club Drive, Crawfordville, Florida 32327. The Association Board of Directors may change the location of the principal office of the Association and its mailing address from time to time as provided by law.

# **ARTICLE 3 – DURATION**

The period of duration of the Association is perpetual.

#### **ARTICLE 4 – PURPOSE**

The Association does not contemplate pecuniary gain or benefit, direct or indirect, to its Members. By way of explanation and not limitation, the purposes for which the Association is organized are:

(a) To be and constitute the Association to which reference is made in the Declaration of Restrictive Covenants further referred to as the Declaration, to perform all obligations and duties of the Association, and to exercise all rights and powers of the Association, as set forth in the Declaration, these Articles of Incorporation and the Bylaws of the Association as provided by law;

- (b) To provide an entity for the maintenance, management, and control of certain property located in Wakulla County, Florida, which property is referred to as Wildwood Country Club and is subject to the Declaration of Restrictive Covenants for Wildwood Country Club, which is recorded in the Public Records of Wakulla County, Florida, as same shall from time to time be amended and supplemented (the "Declaration").
- (c) To provide for the ownership, operation, maintenance and preservation of any Common Areas and for the maintenance and improvement of any easements granted to the Association within the lands subject to the Declaration of Restrictive Covenants and such additional properties as may be added thereto from time to time by annexation or otherwise as provided in the Declaration of Restrictive Covenants and in these Articles; and
- (d) To promote the health, safety, and welfare of its members and the residents within the Association Property and any additions thereto as may hereafter be brought within the jurisdiction of this Association.

#### **ARTICLE 5 – POWERS**

The powers of the Association shall include and be governed by the following provisions:

General Powers. In furtherance of its purposes, the Association shall have the following powers, which, unless indicated otherwise by the Declaration of Restrictive Covenants or Bylaws of the Association, may be exercised by the Board of Directors:

- (a) All of the powers conferred upon not-for-profit corporations by common law and Florida Statutes in effect from time to time; and
- (b) All of the powers necessary or desirable to perform the obligations and duties and to exercise the rights and powers set out in these Articles, the Bylaws and the Declaration, including, without limitation, the following:
  - (1) The power to fix, levy, and collect adequate Assessments and other fees against Lots, as provided in and subject to the Declaration or Bylaws;
  - (2) The power to expend monies assessed and collected for the purpose of paying the expenses of the Association, including, without limitation, costs and expenses as provided in the Declaration or Bylaws;
  - (3) The power to manage, control, operate, maintain, repair, and improve the Common Areas;
  - (4) The power to purchase supplies and materials and lease equipment required

for the maintenance, repair, replacement, operation, and management of the subdivision as provided in the Declaration;

- (5) The power to insure and keep insured Association Property and the Common Areas;
- (6) The power to employ or retain the personnel, vendor, or managers required for the operation and management of the Association and the subdivision;
- (7) The power to pay utility bills for utilities serving the Common Areas;
- (8) The power to pay all taxes, licenses, assessments, or other governmental assessments which are liens against the Association Property or Common Areas;
- (9) The power to establish and maintain a reserve fund for capital improvements, repairs, and replacements;
- (10) Subject to applicable laws, ordinances, and governmental regulation, the power to control and regulate the use of the Lots and Common Areas;
- (11) The power to acquire (by gift, purchase, or otherwise), own, hold, improve, build upon, operate, maintain, convey, sell, lease, transfer, mortgage, dedicate for public use or otherwise dispose of real or personal property in connection with the affairs of the Association;
- (12) The power to make reasonable Rules and Regulations regarding Common Areas and Lot use and to amend the same from time to time;
- (13) The power to enforce by any legal means the provisions of these Articles, the Bylaws, the Declaration, and the Rules and Regulations promulgated by the Association from time to time;
- (14) The power to borrow money, pledge, deed in trust, or hypothecate any or all of its real or personal property as security for money borrowed or debts incurred. A majority of the membership shall first approve any borrowing or other indebtedness that exceeds \$20,000.00.
- (15) The power to select depositories for the Association's funds, and to determine the manner of receiving, depositing, and disbursing those funds and the form of checks and the person or persons by whom the same shall be signed, when not signed as otherwise provided in the Bylaws;
- (16) The power to enter into a contract with any person, firm, corporation, or

- management agent of any nature or kind to provide for the maintenance, operation, and administration of the Association and the subdivision.
- (17) The power to appoint committees as the Board of Directors may deem appropriate; and
- (18) The power to collect delinquent Assessments and fines by suit or otherwise, to abate nuisances and to fine as provided in the Bylaws, suspend use or voting rights, enjoin or seek damages from Owners for violation of the provisions of the Declaration, these Articles of Incorporation, the Bylaws or the Rules and Regulations; and
- (19) Subject to the terms of the Declaration, the power to bring suit and to litigate on behalf of the Association; and
- (20) The power to provide any and all supplemental municipal services as may be necessary or proper; and
- (21) The Power to grant easements as to the Common Area to public and private utility companies, and to the public bodies or governmental agencies or other entities or persons, without cost or charge, where convenient, desirable or necessary in connection with the development of the properties, and the providing of utility and other services thereto; and
- (22) The power to possess, employ and exercise all powers necessary to implement, enforce and carry into effect the powers above described.

Emergency Powers. The Association may also exercise those emergency powers stated in section 720.316, Florida Statutes when a state of emergency is declared for Wakulla County.

Limitations and Restrictions. The foregoing enumeration of powers shall not limit or restrict in any manner the exercise of other and further rights and powers which may now or hereafter be allowed or permitted by law; and the powers specified in each of the paragraphs of this Article are independent powers, not to be restricted by reference to or inference from the terms of any other paragraph or provision of this Article.

#### ARTICLE 6 – QUALIFICATIONS OF MEMBERSHIP

General. The Association shall be a membership corporation without certificates or shares of stock. The record title owner ("Owner") of each Lot or Unit within the lands subject to the Declaration ("Lot") shall be a Member of the Association and shall be entitled to vote as provided in the Declaration and the Bylaws. The rights and obligations of a Member may not be assigned or delegated except as provided in the Declaration, these Articles of Incorporation, or the Bylaws

of the Association, and shall automatically pass to the successor-in-interest of any Owner upon conveyance of such Owner's interest in the Lot. Change of an Owner's membership in the Association shall be established by recording in the Office of the Clerk of the Circuit Court of Wakulla County, Florida, a deed or other instrument establishing record title to a Lot. Upon such recordation, the Owner designated by such instrument shall become a Member of the Association and the membership of the prior Owner shall terminate.

Limitation on Transfer of Shares of Assets. A member cannot assign, hypothecate or transfer in any manner his or her share in the funds and assets of the Association, except as an appurtenance to the member's Lot.

#### ARTICLE 7 – VOTING RIGHTS

Subject to the restrictions and limitations hereinafter set forth, all Members shall be entitled to one (1) vote for each Lot that they own. When one or more persons hold such interest or interests in any Lot, all such persons shall be Members, but only one (1) vote may be cast for the Lot in the manner provided in the Association's Bylaws. Except where otherwise required under the provisions of the Governing Documents or by law, the affirmative vote of the Owners of a majority of Lots represented at any meeting of the Members duly called and at which a quorum is present, shall be binding upon the Members.

#### ARTICLE 8 - BOARD OF DIRECTORS

The affairs of the Association shall be managed by a Board comprised as provided in the Bylaws. Elections shall be conducted in the manner provided in the Bylaws.

# ARTICLE 9 – INDEMNIFICATION OF OFFICERS, DIRECTORS AND COMMITTEE MEMBERS

Every Director, Officer and Committee Members of the Association shall be indemnified by the Association against all expenses and liabilities, including legal fees, reasonably incurred by, or imposed upon him or her in connection with any proceeding or the settlement of any proceeding to which he or she may be a party, or in which he or she may become involved by reason of his or her being or having been a Director, Officer or Committee Member of the Association, whether or not he or she is a Director, Officer and Committee Member at the time such expenses are incurred, except when the Directors or officer is adjudged-guilty of willful and wanton misfeasance or malfeasance in the performance of his duties provided that in the event of a settlement, the indemnification shall apply only when the Board of Directors approves such settlement and reimbursement as being for the best interests of the Association. The foregoing right of indemnification shall be in addition to and not exclusive of all other rights-to which such Director or officer may be entitled.

# ARTICLE 10 - OFFICERS

The officers of the Association shall be a President, a Vice President, a Secretary, and a

Treasurer. The Bylaws of the Association shall specify the election, term, qualifications and duties of Association officers and any assistant officers.

# ARTICLE 11 - REGISTERED AGENT

The street address of the registered office of this corporation is 1689 Mahan Center Blvd., Suite B, Tallahassee, Florida 32308 and the name of the Registered Agent of this corporation at that address is Anderson, Givens & Fredericks, PA. The Association Board of Directors may change the Association's registered office and registered agent from time to time as permitted by law.

#### **ARTICLE 12 - BYLAWS**

The Association Bylaws may be amended in the manner provided by the Bylaws.

## **ARTICLE 13 – AMENDMENTS**

These Articles may be amended in the following manner:

- (a) Notice of the subject matter of a proposed amendment shall be included in the notice of any meeting at which a proposed amendment is considered.
- (b) An amendment to these Articles of Incorporation may be proposed by either the Board of Directors of the Association or by ten percent (10%) of the Members of the Association petitioning for a Membership meeting. Upon any amendment or amendments to these Articles of Incorporation being proposed by the Board of Directors or Members, such proposed amendment or amendments shall be transmitted to the President of the Association, or the acting chief executive officer in his or her absence, and a Meeting of the Members of the Association shall be called not later than sixty (60) days from the Presidents receipt of the proposed amendment or amendments. Except as elsewhere provided, an amendment must be approved by at least two-thirds (2/3) of the Members voting, in person or by proxy, at a meeting held for such purpose.
- (c) Limitation and Recording. As elsewhere provided, however, no amendment shall make any changes in the qualifications for membership nor in the voting rights or property rights of Members without approval in writing by all Members so affected. No amendment shall be made that is in conflict with the Declaration. Amendments to these Articles shall become effective upon recordation unless a later effective date is specified therein.
