LIST OF DOCUMENTS INCLUDED

- 1) Two pages to be sent to the US Department of State. One page is Affidavit of Citizenship Status, Attention: US Secretary of State, and the other is a request to have your citizenship status filed, Attention: Administrative Records.
- 2) Directions-" Filing 'Citizenship' Evidence with Passport Application Original or Renewal"

For educational purposes these documents are added:

- 1) A two-page document called "How to Escape the Matrix: "RE-Patriate"
- 2) A two-page document called "US Citizens are PROPERTY: US Nationals/State Citizens ARE NOT...Which DO YOU Want to Be?"
- 3) A 5-page document "Right to Drive Without a State License"

INSTRUCTIONS ON HOW TO FILE DOCUMENTS WITH THE NATIONAL SECRETARY OF STATE

- 1) Fill out the Affidavit of Citizenship Evidence BUT DO NOT SIGN IT until the Notary says to. You can go to your bank and get a Notary to sign the document for free.
- 2) Fill out the second document-request to have your citizenship status filed-and sign it.

MAKE COPIES OF THESE DOCUMENTS TO BE SENT IN. Always keep your original documents in a file of your own. You may need to make copies from these originals later.

Place these two copies of your documents in an envelope addressed to the US Department of State, 2201 C. Street, Washington, D.C. 20520. Take this to the post office and request a return receipt. This receipt is a green form that you must fill out so that it will be mailed back to you as proof that the documents were signed for. Keep this return receipt with your other original documents.

This is not legal advice. It is up to each person to do your own research and understand your new status. A change in status does not give anyone the right to disobey any laws.
