- 1. Establish Quorum Quorum established by President, Larry Lookingbill.
- 2. <u>Welcome/Introductions</u> Meeting called to order by Larry Lookingbill. He welcomed all attending virtually and in person. Quarterly meeting schedule reviewed, and members encouraged to join. Quarter 3 meetings will be July 18&19 in Austin, TxENA General Assembly for which we will have 2 delegates. General Assembly is hybrid, so a virtual link is available.

<u>TCENA updates</u>: **TCENA chapter meetings** are scheduled every other even month (Feb, April, June, August, October, December) on the 1st Tuesday of the month at 7 p.m. Most are hybrid meetings with an in-person location and a virtual ZOOM link. Our next meeting will be June 3, 2025 at 1900 at Baylor Scott & White All Saints, Fort Worth, thank you to Colyn Turnbow for arranging.

5. Treasurer Report by Jeannette Kohley presented. Motion and second to accept as presented passed. Report attached to minutes. See Fund Raising below.

6. Officer Reports:

a President (Larry Lookingbill) Announced EECU account signature cards updated. Account credit cards will be issued only to 3 officers: President, President-elect and treasurer. This is in compliance with Texas and National ENA policies for card holders. Motion second and accepted by member vote.

- Reported that IRS Form 990 has been filed, copies to Texas and National ENA.
- b President-Elect (Colyn Turnbow) noted the links provided in the minutes and meeting slides for references for members including how to contact board members should they have any questions.
- c Immediate Past President (Kris Powell) Planning a TCRN Review course date TBD. Also considering a CEN Review course due to requests and is calling for potential instructors to contact her if interested. Instructors should be CEN.
- d Secretary (<u>Barry Hudson</u>) 1. The reported trouble with the golf challenge fundraiser due to a change in management has been resolved. The Golf Challenge should continue with 3 courses willing to participate. Challenges will be scheduled starting in June and continue to the end of the year.
 - 2. Tarrant County 199 Presented the chapter report at the Texas State General Assembly meeting on April 12. Report attached.
- e <u>Treasurer's Report (Jeannette Kohler)</u> Treasurer's report (attached hereto) was presented. Motion, second and accepted by member vote as presented.

7. Committee Reports:

- a <u>Membership</u> (<u>Susan Raven</u>) Members = 561 members, including 184 auto renewals. Focus should be on new members including students and retaining current.
- b <u>Education (Pat Yancey)</u> More information on our <u>TCENA.org/education</u> site. Pat shared there were 5 TNCC and @ ENPC classes with 56 participants. This generated revenues of \$250 to the chapter. She also estimated a revenue of \$300 for the third quarter from these classes.
- c Quality, Safety & Injury Prevention (Lynn Kelley): Lynn shared she will reschedule the committee's next meeting as it is during EN24. Shared we will have water safety events every Tuesday at Cherry Park, Weatherford starting June 10. We will conduct a class every hour starting at 10am during each event. These community events target drowning prevention meeting our 2025 goal.
 - i Pediatric Readiness Barry Hudson and Amy Tucker (Regional PECCs), conducted a Train the Trainer presentation at the NCTTRAC office to Area E HPECCs/PPECCs on April 23. There were approximately 23 new Hospital Pediatric Care Coordinators (HPECC) present. The HPECCs were from DFW area hospitals in RAC area E.
