I. PURPOSE:

The purpose of this policy is to define the rules for voting by an electorate in an election for the Tarrant County Emergency Nurses Association (TCENA) Board of Directors.

## II. DEFINITIONS

An electorate is the total number of voting members participating in an election.
An office of the organization includes an office of the Board of Directors identified in the bylaws of the Tarrant County Emergency Nurses Association Inc.

A plurality vote describes the circumstance when a candidate polls more votes than any other candidate but does not have to be a majority of the electorate to win the election.

A majority vote describes the circumstance when a candidate polls a majority vote and, if a majority is required, wins the election. A majority vote is $50 \%$ of the electorate plus 1 . When more than two candidates in an election, and none receive a majority, another (run-off) election is held with the two candidates receiving the highest polled.

## III. PROTOCOL/PROCEDURE:

A. When nominations for candidates are received and vetted in advance, the method for voting for candidates of an office of the organization shall be by written or electronic ballot.
B. Candidates for office shall be listed on a ballot and space provided for a write-in candidate will be provided.
C. The electorate shall consist of the current members of the board of directors for TCENA, and any active member of TCENA present at the meeting in which an election is held.
A. Active members of the organization shall be identified prior to the poll of voters in order to distribute a ballot to each.
D. If the election is by ballot of those present at a meeting:

1. Each member of the board and each active TCENA member will have one vote.

2. There is no vote by proxy.
3. Members attending a meeting virtually, must be present at the time of the poll and their presence is considered in attendance at the meeting.
4. The poll of the votes will be collected and tabulated by the president or designee appointed by the President
i. In an uncontested election, a voice vote by acclamation is permitted.
ii. In a election with more than one candidate running for an office, the plurality vote will determine the election.
5. Results of the tabulation will be given to the president and the president will announce the result of the poll.
6. If the election is by electronic ballot, a ballot or other mean of voting will be provided to each eligible voter of the electorate identified in rule \#3.
7. Electronic ballots are tabulated by the provider of the ballot.
8. The president will announce the results of the poll received.

## 5. The President's vote

A. According to Robert's Rules of Order, the president always votes in a ballot vote.
B. The policy of this organization is the president's vote is used only to cast a tiebreaking vote, therefore the president's vote is held and only used to settle a tie vote.
