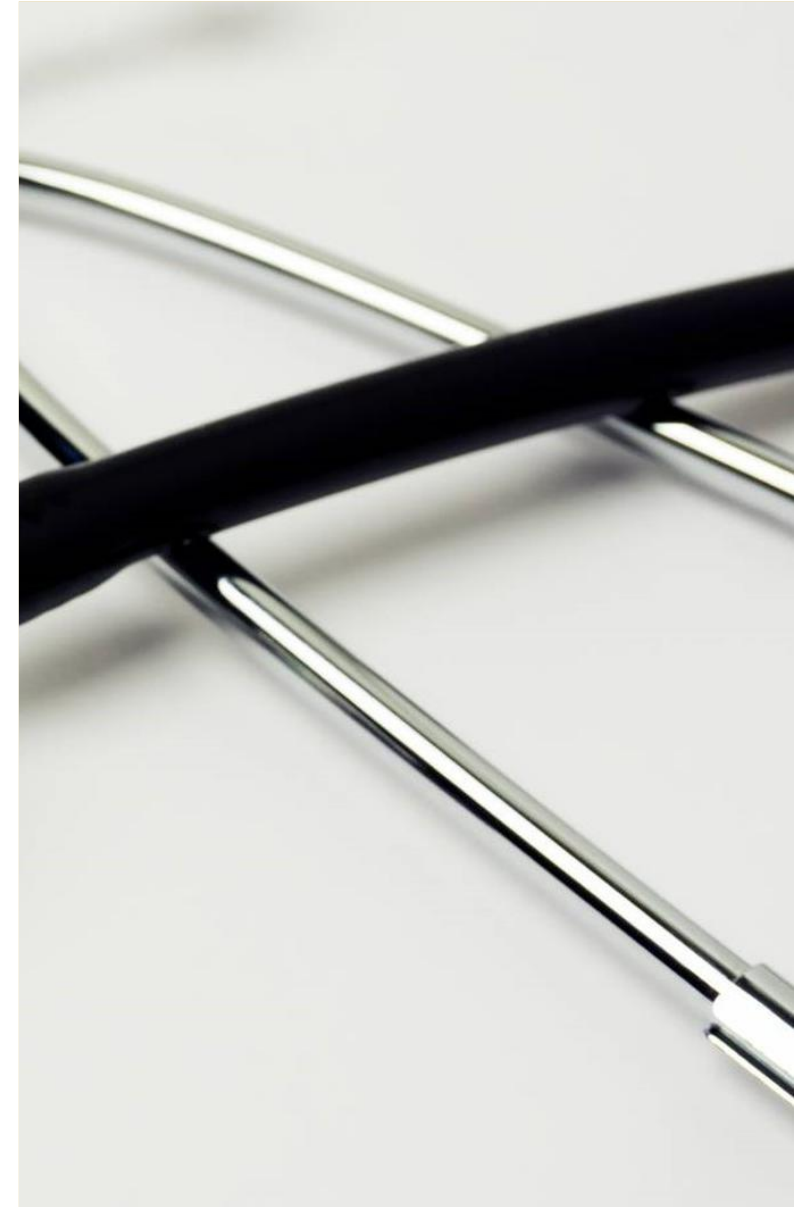

**2022 Call to Order (Larry Lookingbill)**

- 
1. Establish Quorum – Quorum established by President, Larry Lookingbill.
  2. Welcome/Introductions – Meeting called to order by Larry Lookingbill. He welcomed all attending virtually and in person. Introductions made by board members, members, first-time attendees, guests and students. Certification recognitions: CEN, CPEN, TCRN, CFRN, CTRN, CBRN, FAEN, and others. December minutes presented for any corrections or changes. MOTION and second to approve as presented. Minutes approved and will be posted to the TCENA website.

3. General updates - Kris Powell provided general updates:  
National Updates: The [tiered membership cost](#) reviewed and link provided in slides which is also available on [ena.org](#) website. Kris asked for members to share this information to fellow teammates to encourage membership. Clarified that once you join ENA you are automatically a member of TCENA, Texas ENA and National member. This year the ENA Annual meeting will be in Las Vegas, NM, September 4-7, 2024. Call for content 2025 [ENA Leadership Conference](#) which will be January 29-31, 2025 in Louisville, KY, abstracts are due August 26, 2024. [Call for National Committee and Workgroup Volunteers](#), opens on August 2 and application deadline September 13, 2024.

Quarterly meeting schedule reviewed, and members encouraged to join. Quarter 2 meetings will be April 11 and 12 in Tyler, TxENA General Assembly for which we will have 2 delegates. General Assembly is hybrid, so a virtual link is available.

TCENA updates: **TCENA chapter meetings** are scheduled every other even month (Feb, April, June, August, October, December) on the 1<sup>st</sup> Tuesday of the month at 7 p.m. Most are hybrid meetings with an in-person location and a virtual ZOOM link. Our next meeting will be April 1, 2025 at 1900 at THR WillowPark, thank you to Larry Lookingbill for arranging.

4. Officer Reports:
- President (Larry Lookingbill) Announced EECU account signature cards updated. Account credit cards will be issued only to 3 officers: President, President-elect and treasurer. This is in compliance with Texas and National ENA policies for card holders. Motion second and accepted by member vote.  
Reported that IRS Form 990 has been filed, copies to Texas and National ENA.
  - President-Elect (Colyn Turnbow) noted the links provided in the minutes and meeting slides for references for members including how to contact board members should they have any questions.

- c. Immediate Past President (Kris Powell) – Planning a TCRN Review course date TBD. Also considering a CEN Review course due to requests and is calling for potential instructors to contact her if interested. Instructors should be CEN.  
National awards applications nominations should submitted before the end of February. Kris also announced the TNAC (Texas Nurse Advance Course) modules and simulation was awarded by TxENAA at the first quarter meeting to Kristin Malvik.
- d. Secretary (Barry Hudson) – The reported trouble with the golf challenge fundraiser due to a change in management has been resolved. The Golf Challenge should continue with 3 courses willing to participate. Challenges will be scheduled starting in April and continue to the end of the year.
- e. Treasurer's Report (Jeannette Kohler) – Treasurer's report (attached hereto) was presented. Motion, second and accepted by member vote as presented.

Shared we have had 4 pool and water safety events (photos in slides), very successful and fun community events targeting drowning prevention meeting our 2024 goal.
