We are all responsible for keeping the area clean around our ring. No exercise pens are allowed in the building.

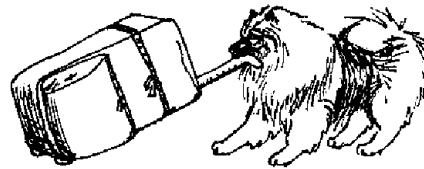
