Instead, I have been **belittled, gaslit, controlled, and repeatedly disrespected** by someone who should have been my supporter. He has attempted to falsify legal documents in my name without consent. He has **pressured me for money** while engaging in reckless personal spending. He has **denied my rights to self-determination**, often trying to block my decisions or misrepresent them in conversations with others. In short, he has **used every tool at his disposal—emotional manipulation, coercion, financial pressure, and legal intimidation—to prevent me from succeeding.**

Despite this, I have never stopped striving for a better life. But I now recognize that I **cannot grow, heal, or build** while under constant threat and emotional surveillance.

Therefore, I request that the court:

1. Order **Raymen Khandokar** to **vacate the household** or maintain a **legally enforced distance** from me for at least **60 days** to allow for healing, safety, and clarity.
2. Prohibit him from **filing any legal documents** on my behalf or referencing me in legal filings without my **explicit written consent**.
3. Review any **pending filings** or recent actions involving my name to determine if abuse of process or coercion has occurred.
4. Recognize that I am an **independent adult**, fully capable of managing my legal, financial, and personal affairs, and **rescind any perceived or assumed authority** he may claim over me.

I am not submitting this request lightly. I am submitting it because I am trying—**desperately and sincerely—to build a life of purpose**, and I need the court's protection to do so without the constant fear of sabotage, instability, or personal attack.

This request is made in the interest of **mental, emotional, and physical safety**, as well as the **freedom to build a better future without interference from those who wish to see me broken.**


