## Formal Statement & Request for Legal Action

**Subject:** Urgent Protective Action and Legal Documentation Regarding Repeated Abuse – June 29th, 2025

**Dear Mr. Fetter,**

I am writing to formally document and request immediate legal follow-through regarding the **ongoing pattern of abuse by my father**, which escalated again on **June 29, 2025**, prompting a 911 emergency call. This call was recorded live and responded to by **three deputies**, including a familiar officer with whom I previously discussed keeping my father at bay and treating him with calm, disciplinary clarity. His return was both symbolic and significant, signaling a growing awareness of my situation within local law enforcement.

To reinforce the depth and scope of the situation, I also provided **three psychotherapy shepherd cards** directly to the officers, inviting them into a trauma-informed psychological framework rather than pure force dynamics.

This follows the recent submission of my **Letter of Intent and Request for Protections** to the Florida Highway Patrol (FHP), the Orange County Sheriff's Office (OCSO), and other appropriate parties. These documents clearly outlined my desire for peace, protection, and lawful separation from a household of repeated coercion and harm.

## **I Am Now Requesting the Following Immediate Actions:**

### 1. **Legal Case Initiation or Filing**

That a formal case or restraining action be opened under your guidance based on accumulated evidence (calls, letters, personal testimony).

### 2. **Preservation of Evidence**

That all audio and video related to the 911 call and police response on June 29, 2025, be secured and retrieved through appropriate legal channels.

### 3. **Acknowledgment of Past Submissions**

That my previously submitted documentation—including symbolic therapeutic tools—be reviewed and entered into an official protective case file.

### 4. **Federal Review**

This situation represents **a potential failure of local systems** to provide adequate protection in the face of clearly documented ongoing harm. I am escalating this letter to the **Department of Justice** and the **Supreme Court of the United States** in the interest of visibility, safety, and national accountability.

  - I now seek **legal separation, protective oversight, and constitutional security** under the law.


