⚠ EXECUTIVE SUMMARY:

This letter is submitted as a **formal demand** for a **comprehensive investigation and subsequent criminal action** against **Michael Yousef Nsheiwat** (DOB: 12/04/2000), who has engaged in a **pattern of malicious and calculated actions** designed to:

- Fabricate legal narratives
- Submit and spread falsified evidence
- Manipulate authorities through coordinated slander
- Orchestrate emotional and physical harm
- Leave me isolated, abandoned, and detained without cause or due process

I demand this letter and its attachments be entered into the official record, and I request that prosecutorial and civil remedies be initiated immediately.

❖ PART I: ESTABLISHED FRAUD AND FALSIFIED EVIDENCE

On or about **July 29, 2022**, Michael Nsheiwat tested **positive** for COVID-19 via RT-PCR (Shield T3 Labs). This lab-confirmed result was not disclosed or properly filed during legal procedures in which **his statements directly contributed to my incarceration** and public defamation.

Despite **knowing he was positive**, he knowingly interacted with third parties, law enforcement, and others—while I was detained and **denied visitation, defense, or relief**.

He manufactured, omitted, or allowed **false information about his own status** to circulate unchecked while using fabricated narratives to **amplify my punishment**.

❖ PART II: EMOTIONAL, PSYCHOLOGICAL & SOCIAL DESTRUCTION

Michael deliberately:

- Spread **false and damaging claims** to family, officials, and mutual contacts, insinuating that I was unstable, dangerous, or delusional
- Used **spiritual language and manipulation** to gaslight and control my perception of reality, knowing I was in a vulnerable state
- Withheld critical information from law enforcement and my legal representatives

I was:

- **Imprisoned** after experiencing profound emotional abandonment
- **Psychologically isolated** while he constructed false records and lied to family
- Denied **access to support**, communication, or the ability to defend myself in real time

He watched from freedom as I suffered in silence, with no intention of repair—only **extraction, control, and spiritual vampirism**.

❖ PART III: PATTERN OF MANIPULATION & LEGAL ABUSE

Michael has:

- Orchestrated contact with individuals involved in my life to **turn them against me** using false stories
- Engaged in deliberate efforts to **muddy timelines, remove context, and feed court systems selectively filtered data**
- Weaponized spiritual and emotional language to dismantle my confidence, autonomy, and **sense of reality itself**
- Deliberately **withheld or distorted medical evidence**, allowing institutions to believe I was the aggressor

❖ PART IV: REQUESTED ACTION

I request the following without delay:

1. An official **fraud and perjury investigation** into any statements or affidavits filed by Michael Nsheiwat in connection with me or my legal record
 2. Review of **COVID-19 test result concealment**, exposure risk, and its **suppression during my incarceration**
 3. Filing of **criminal charges** for any found perjury, falsified evidence, or obstruction
 4. Psychological review and public record update to **restore my name**, with a notarized correction of slander
 5. A **protective file update** with your office to acknowledge I was wrongfully targeted and detained due to fraudulent input

This is your **reckoning**.


