**Ducks: 5 head of crossbred ducks (limited to 12 runs per arena trial)**

**Sheep: 4 head of Dorper cross sheep (limited to 20 runs per arena trial)**

**Cattle: 3 head of beef cattle (limited to 10 runs per arena trial)**

**AWARDS:**

**Placement ribbons 1<sup>st</sup> – 4<sup>th</sup>. Rosettes for HIT Aussie and Other Breed. Other awards for HIT will also be given at the end of the day.**

**A Special Award will be given for HIGH COMBINED WTCH, Non-WTCH, STARTED and OTHER BREED. A dog must be entered and run in all eligible arena classes. Scores from arena runs will be totaled to arrive at “HIGH COMBINED”.**

From Brenham: Go approximately 16 miles east on Hwy 290. Turn right onto Sorsby.

From anywhere: At the dead end of Sorsby, turn left on Austin Branch and immediately right on Kmiec. When the road turns to the right, drive straight into the driveway.

**RESPONSIBILITIES**

**Owners of dogs will be responsible for all injuries to livestock and will pay for veterinary services or, if necessary, replacement cost. Cattle= \$Fair market value, Sheep = \$300/head, Ducks = \$70/head.**

**Owners/handlers are responsible for their dog(s). Dogs must be crated or on lead at all times, except when competing.**

**Children must be under direct adult supervision at all times.**

**Central Texas Working ASA, its' officers and members assume no responsibility for any loss, damage or injury sustained by an exhibitor, handler, dog, property, child or spectator. Trialing is inherently dangerous. Ground/footing is uneven. Knowing this, you assume full liability for yourself, dog and stock if any damage is caused by you or your dog to stock or others. We thank you for cleaning up after your dogs.**

## **ENTRIES & FEES**

**No telephone, facsimile, email or incomplete entries will be accepted. All entries must be on latest ASCA entry forms with proper fees included (<http://www.asca.org/portals/O/stockentry.pdf>)**

**The entry limit per Judge will be accepted in postmark order. If a class of stock is full the dog will be put on a waiting list in order of receipt.**

**Any entries received postmarked after pre-entry closing date will be placed on the waiting list, in postmarked order. Additions will be made prior to the start of the trial from the waiting list and are at the discretion of CTWASA.**

***Substitutions will be allowed with the following restriction: the substitute dog must be owned by the original entrant.***

**Entry fees will not be refunded in the event a dog is absent, disqualified by a judge, or barred from competition by the trial committee. Entry fees will be refunded if excused in writing by a veterinarian.**

**Entry fees will not be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire and/or dangerous weather conditions, acts of God, public emergencies, acts of public enemy, strikes or other causes beyond the control of CTWASA.**

**Selling runs is not permitted unless the trial is full. If the trial is full and you wish to sell a run, the transaction must be handled by the trial secretary. All offers to buy or sell runs must be submitted to the trial secretary at least one hour before the trial starts.**

**Any checks returned for insufficient funds will be considered a void entry. There is a \$25 service charge for returned checks. If entries are resubmitted, payment must be in the form of cash, Money Order or Cashiers' Check.**

**This trial is open to all ASCA approved herding breeds. Non-ASCA dogs may enter the stock trial without a tracking number; however, only those with a tracking number will be awarded ASCA titles upon completing title requirements.
