The Consumer Resource Center (CRC) assists the Office of Consumer Protection (OCP) by providing information and complaint forms to consumers, and by preliminarily reviewing complaint forms received. CRC staff recently reviewed your complaint to determine whether the information provided was sufficient to warrant further inquiry by OCP.

As a state agency, OCP is limited by statute and its resources as to the types of cases that it may investigate and prosecute. The office is primarily responsible for taking appropriate action against individuals or businesses who engage in unfair or deceptive trade practices which affect consumers. The office collects and maintains consumer complaints in a database. With that information, the office looks for patterns within an industry or in a particular business. While many complaints are investigated, isolated complaints may be placed in the database without further action. That does not mean that the business is right. In some cases, OCP will investigate an isolated incident if they find that the impact of investigating that specific case may have a far-reaching effect on consumers or on that industry in general.

Upon preliminary review by CRC, your complaint is being added to OCP's database and closed without additional investigation by that office. If the office receives similar complaints, the information you have provided may be helpful in future investigations. We suggest that you attempt to deal directly with the individual or business you are complaining about to try to resolve your complaint. Should your attempt fail, you may consider taking small claims court action if the monetary amount you seek is within the \$5,000.00 limitation of the small claims court. You may also consider seeking legal advice from an attorney who can best advise you as to other actions which may be available to you.

Thank you for sharing your concerns with OCP. Again, your information is important to us and helps OCP to understand what is going on in the industry and to recommend needed changes in consumer protection laws. The Regulated Industries Complaints Office (RICO), Consumer Resource Center (CRC), received and reviewed your complaint against The AOA of Canterbury Place and allegations of failure to provide specific condominium records after multiple verbal and written requests to the association and/or the association's attorney.

RICO is limited as to the types of cases that we may investigate and prosecute. This office is primarily responsible for taking appropriate action against individuals or businesses that violate the licensing laws for the profession or vocation they are engaged in. However, not every dispute amounts to a licensing law violation. If a licensing law violation is not established based on the information provided to us, our office may not be able to investigate your concerns.

After reviewing your complaint, and pursuant to our December 30, 2025 telephone conversation, it appears the information you submitted is not sufficient to determine a licensing law violation on the part of The AOA of Canterbury Place. Therefore, your complaint will be inactivated and our office will take no further action at this time.
