INTRODUCTION

MESSAGE FROM THE FOUNDER

As we, the Safe & Together Institute, look back at 2019, our heads are swirling with excitement about all of it. It's difficult to even catalog all that has happened. So, before you turn to review our key achievements and milestones in the following pages of this first-ever Impact Report, I want to first reconnect you to our vision and mission, and then share with you our direction for 2020.

It is our desire to close the historic gap between practice in the child maltreatment and domestic violence fields, shift the emphasis of practice away from "failure to protect" to accountability and toward intervention with perpetrators as parents.

Our organization is dedicated to transforming the way individual practitioners, agencies and communities respond to families impacted by domestic violence perpetrators' behaviors.

The following concepts are key drivers of our work:

- Domestic violence perpetration is a parenting choice.
- · Domestic violence perpetrators' behaviors and choices impact child and family functioning.
- Child-centered systems, particularly statutory child welfare, are natural allies of domestic violence survivors, and can be drivers of domestic violence-informed practice in their communities.
- Gender double-standards are preventing us from perceiving the parenting strengths of mothers and describing the impact, positive and negative, that father's choices have on child and family functioning.
- Systems, including child welfare and family courts, need to get better at assessing men as parents, and need to stop treating them as disposable or privileged.
- A global network of professionals trained to implement a perpetrator pattern-based approach to domestic violence can change outcomes for children, adult survivors and families.

These concepts get expressed in our trainings, consultations, research, trainer certification program, conferences, organizational assessments, podcast and e-learning. In 2019, we have deepened our efforts in all these areas. For example, we are released new training and resource materials for supervisors and managers with a strong focus on worker safety. Research and our work with agencies helped us identify that workers' fears about safety is one of the major barriers to implementing the Safe & Together Model. We saw exponential growth in our e-learning implementation.

Over 21,000 individual e-learning licenses show how critical online learning is to sustainable change using new trainers and partner agencies across the globe. This program allows local agencies across the globe to achieve their goals of becoming domestic violence-informed at a lower cost with local staff.

At the beginning of 2020, we are already excited about what we will be accomplishing this coming year. This will be our second year where we will be having Safe & Together Model conferences in three continents. We hope to see you at one of these events. Each of our conferences, (Asia Pacific event in Australia; European event in the UK; and North American event in the United States) serves as our "touchstone" event in each region. We hope people will return to annually to stay connected to our newest thinking and materials alongside the work of our partners.

We will be releasing our fifth e-course "Partnering with Survivors". This course will increase the capacity of professionals and agencies to become effective allies to adult survivors around the needs of their children.

We will be strengthening the Trainer Certification Program (TCP) through the release of our first fully online training credential: The Supervisor Training Curriculum Credential. This credentialing course will allow Partner Agencies to add another Safe & Together Model curricula to their trainers' approved delivery lists. In addition, we have plans for improved localization of training and resource material as well as new consulting services for Partner Agencies to help them achieve their goals.

We will also continue to release new episodes of our brand new podcast "Partnered with A Survivor" which widens out the availability of Safe & Together related content, and is part of our commitment to include the voices of survivors throughout our work.

These are just a few things we have planned for 2020. I invite you to attend our conferences, take an inperson or online training, listen to our podcast and visit us on social media. Please join with us in making the world safer and stronger.



*Other sectors included Behaviour Change Program, Parole/Probation, Law Enforcement, Substance Abuse Treatment, Mental Health Treatment, Legal


TEST SCORES

VISION

Continuously refined through years of experience implementing the Model across the United States and other countries, it can help improve competencies and cross-system collaboration.

The Safe & Together™ Model is an internationally recognized suite of tools and interventions designed to help child welfare professionals become domestic violence-informed.

This child-centered model derives its name from the concept that children are best served when we can work toward keeping them safe and together with the non-offending parent (the adult domestic violence survivor). The Model provides a framework for partnering with domestic violence survivors and intervening with domestic violence perpetrators in order to enhance the safety and wellbeing of children.

Our mission is to create, nurture and sustain a global network of domestic violence-informed child welfare professionals, communities and systems.

HIGHLIGHTS

Queensland Office of the Child and Family Official Solicitors: Domestic Violence-Informed Practice Training for Lawyers

The Institute developed and delivered two 2-day practice trainings for lawyers in Queensland. This practice training built upon many of the CORE practice areas and cross cutting themes and connected the concepts to the practice of lawyers who make recommendations to the court regarding child safety involved cases including legal aid, best interest lawyers and child protection lawyers.

Communities of Practices

Queensland Child Safety funded and held two Communities of Practice (COP). COPs support systems to shift practice, culture and systems in the local context. Participants were selected based on a shared purpose to improve child welfare/domestic violence work as change agents across multi-agency networks. COPs included practitioners from a variety of community sectors such as Child Safety, law enforcement, men's behavior change programs, children's and family service providers. All 48 participants attended a 2-day training and six workshops to support the implementation of the Model into their local practice. Key learnings from the COPs were: The importance of documentation and information sharing; the noticeable absence of fathers in documentation; and a need to engage with fathers in a way that supports accountability for their behaviours and behavior change.

EMMA SHAW, BERRY STREET: In 2019, Berry Street created a new role, Project Manager Safe & Together (Emma Shaw), to oversee a coordinated approach to the implementation of The Safe & Together Model across our six regions. Emma, who is our lead Safe & Together trainer, has overseen practice development including the training of over 100 staff in their Specialist Family Violence and Family Services Teams.



KAREN PISCOPO, ANGLICARE: Anglicare has recently developed a new role within their organization, Lead Internal Trainer, specifically to oversee the promotion, marketing and delivery of the Safe and Together model to internal staff and external stakeholders. Karen Piscopo is a Certified Trainer through the Trainer Certification Program and also provides mentoring and consultation to Anglicare staff to assist with implement the model in their day to day practice as well as supports the development of Anglicare's additional Safe & Together certified trainers.



SUCCESS STORY: As a certified trainer within the Department for Child Protection in South Australia I have been keen to train to the Safe & Together Model as often as I can to support a change towards hopefully becoming a more Domestic Violence informed organisation or at least some teams within that.

I have been providing the 4 day CORE and was asked by 2 supervisors at the Child Abuse Report Line / Call Centre to provide some in-service training for the 5 teams working there. This was to see if we could generate some change in assessment, language, and use of the perpetrator behaviour pattern based approach in intakes, so that the change happened at the beginning of the workflow for child protection.

While I was providing a 4 day CORE (2 by 2 days) for the regional office at Mount Gambier they had received some intakes which 'were reading like Safe & Together' and we realised that the Call Centre training was already having some momentum in changing practice and process.

The Call Centre staff had embraced the Safe & Together model and were changing from pre-STI documentation to post STI documentation with some customised, targeted in-service training.

As the Safe & Together trainer this has been so exciting and satisfying to experience and has further cemented the STI model in my mind and work practice. Although a strong STI advocate already this has supported my belief that this model should be the practice model embraced throughout the child protection field. Simple work practice changes can change our work with families and children hopefully leading to better outcomes for everyone.




SUCCESS STORY: In 2019, the Ministry of Defence trained 9 instructors to deliver CORE training localized for the MOD context. The MOD instructors train professionals from a in statutory child protection role and those not in child protective role; midwives and health visitors overseas, and staff from specialist welfare support in RAF and Navy.

These instructors delivered a total of 11 CORE trainings across the UK, Germany and Cypress.

As a result of these efforts, the following are highlights of the impact of their training efforts:

- It prompted several requests from Commanding Officers for enhanced DA training as a result or the support given by AWS.
- AWS also noted successes when referring to children services (CS) using documentation that helped them understand MPH, either resulting in them taking a pattern based approach (and therefore the concerns we had seriously) when they had previously been focusing on the 'incidents' or when the survivor strengths have been made explicit by us in documentation in the context
- AWS has mandated that staff use mapping tools in all its DA cases.

HIGHLIGHTS

First Trainer Certification Program Cohort Trained May 2019:

14 Trainers from the United States and Canada joined the first Trainer Certification Program cohort in May. These trainers have already delivered three CORE trainings and four Overview trainings.

Michigan Justice for Families Friends of the Court Training:

The Institute developed a 2-day training for Friends of the Court in Michigan which included the CORE principles and components and key practice areas connected to the context of custody and parenting time evaluations.

Ohio Supreme Court GAL Training:

The Institute developed, in collaboration with the Ohio Supreme Court, an online course for Guardians Ad Litem. Interviewing family members, reviewing court documents, and writing reports requires knowledge of the non-offending parent's action to protect the children as well as the perpetrator's patterns of behaviors and their impact on child and family functioning to inform appropriate intervention strategies. In this 3-hour course offered through the Judicial College, GALs—and interested community partners—gain critical knowledge and skills to recognize the nuances in domestic violence dynamics and implement practices to foster children's safety and well-being.

Intervening with Perpetrators Training:

In October, four new trainers were certified and nine existing trainers were re-certified to deliver the 2-day Intervening with Perpetrators training curriculum to child protection workers in New Jersey.

















AN DEPARTMENT

LORIDA DEPARTMENT OF CHILDREN AND FAMILIES: For almost 15 years, the Safe &ogether Institute has been partnering with Florida DCF, CLS, CBCs and others including he FCADV to improve outcomes for Florida's families impacted by domestic violence. The Institute's work in Florida is associated with dramatic reductions in out-of-home olacements and neglect court filings. In 2019, the state partnered with Safe & Together to create new Florida-specific tools and trainings, which will be introduced in 2020.

EW MEXICO CHILDREN, YOUTH & FAMILIES DEPT.: The Department has demonstrated deep commitment to becoming domestic violence-informed. The agency is not only seeking to change it's own practice across their agency but is encouraging transformation in their partners. Using a large e-learning component, trainer certification and support for training of key partners like domestic violence advocates, NM CYFD is making major efforts to change outcomes for adult and child survivors The effort includes coaching to help implementation and integration with Safety Organized Practice.



SUCCESS STORY: After completing the Safe & Together training, a Foster Care worker and her supervisor arranged to visit a mom who was in an abusive relationship with a very controlling man. His abusive behavior had ultimately led to the children being removed om the mother in June 2016. When they arrived, the mom was yelling and swearing at them and saying that she was a terrible worker. The supervisor acknowledged that the mom was in a very difficult position and they are aware that her partner controls and monitors most everything she does.

The mother remained extremely defensive and stated she was not comfortable telling the worker or supervisor anything because she did not trust them. They then asked the mother to describe the efforts she had been making to keep her children safe before they were removed. She stated that she always apologized to her partner repeatedly. This would sometimes calm him down. The

mother described that she would often have her boyfriend "cool down" in the bedroom. She would call her ex-husband to have him pick up the children if she felt that the boyfriend would continue to escalate.

The supervisor then stated, "Wow! So you had been doing several things to try to protect your children from his behavior." The supervisor said you could see the life breathed back into the mother. Her entire attitude changed. For the next two hours she spoke freely about what her life has been like and all the ways she had been attempting to shield her children from the abuser. The mother also went into great lengths to describe what she was currently doing to keep herself safe from him even though they were still in a relationship. She had already come up with a detailed plan to leave her boyfriend within the next month or so. The mother stated this was the first time that she felt that anyone understood what she was experiencing. The foster care worker and supervisor reinforced that they wanted to partner with her and help her anyway that they could. As the foster care worker and supervisor were leaving, the mother began to cry and her body shook. She hugged both of them and she thanked them for listening to her. She stated, "I feel really good right now. I finally have hope."

LUKE & RYAN HART



On July 19, 2016, Claire and Charlotte Hart were murdered in broad daylight, by the family's father using a sawn-off shotgun. He then committed suicide. Luke and Ryan Hart, the two surviving sons, now openly share their story to raise awareness of coercive and controlling behavior. So far, they have trained police officers, police community support officers, NHS personnel and legal professionals in the Crown Prosecution Service. They are White Ribbon Ambassadors and Refuge Champions speaking out against male violence toward women and

1ST SAFE & TOGETHER CHAMPION FOR NORTH AMERICA JENNIFER SOSNIAK

Jennifer Sosniak became familiar with the Safe & Together Model via our CORE training in 2015. Her 'a-ha' moment first came as a survivor where the Model, and its clear language of Partnering, helped her to realize that she was living in coercive control. This realization and the tools she acquired in training helped her to heal and move forward both personally and professionally.

Jennifer's experience as a case worker solidified in her that using the Mapping Tool is vital to giving a full and complete account of domestic violence and its impacts on family ecology and child welfare. The Safe & Together Mapping Tool and the Critical Components have given her a concrete container to asses and gather vital information for survivor and child safety. She often repeats in her training of other screeners, "The judge will know what the judge sees," emphasizing the importance of information gathering and mapping perpetrator patterns using the Safe & Together Model.

Jennifer says that the Model has been empowering to her as a survivor as well as a worker. Safe & Together Institute celebrates Jennifer Sosniak as a Champion of the Safe & Together Model, as a Champion of victims, survivors and children.

2019: THE YEAR OF IMPACT



Safe & Together's mission reflects the creation of a global network of domestic violence informed systems that work to keep our children safe and together with the non-offending parent. There are many ways in which this mission is supported, but here, the focus is on the Trainer Certification Program (TCP). In 2019, the TCP has seen an amazing year of DV-informed growth, both in reference to the impact of the individual practices of our certified trainers and the wider influence of our partner agencies.



In 2019, we added 59 new Certified Trainers globally making this year the most expansive yet. The Safe & Together community now encompasses 44 Partner Agencies and 158 Certified Trainers worldwide. Imagine, if each Certified Trainer trained 80 professionals in one year (that equates to 2 CORE trainings), and each of these professionals had a highly conservative case load of 10 families. The impact is barely fathomable – 126,400 families and nearly a quarter of a million children positively affected by the work YOU are doing.

In 2020, we will continue or global reach by offering the Trainer Certification Program in Australia, United Kingdom and in North America. This year will also bring new opportunities to advance your Certification through our upcoming Credentialing Programs.

At Safe & Together, we fully understand that our Partner Agencies are key drivers of our mission, and, we are excited to share that our TCP focus in 2020 will be to support Partner Agencies striving to become DV-proficient. We have heard your requests for support, whether in the form of materials, localisation, organizational assessment, or implementation and are developing pathways for your growth. In coming months, keep an eye out for Health Check, our free online tool for gauging agency strengths and potential areas of growth in becoming more DV-informed.

We believe that 2020 holds the promise of greater outreach and global impact. We have such gratitude for the work you do – your countless hours and your courage to look at the world through a different lens. You are making a difference.

DOMESTIC VIOLENCE-INFORMED ORGANIZATIONAL ASSESSMENT.

All child welfare systems fall on the Continuum of Domestic Violence Practice (CODVP) from "domestic violence-destructive" to "domestic violence-proficient." The purpose of this assessment process is to help child welfare agencies assess where they fall on the CODVP. Using a series of questions focused on both policy and day-to-day practice, the process covers a number of areas including universal screening, high standards for fathers, survivors' protective efforts, services, data collection and more. The assessment provides child welfare agencies with baseline information about their organization's domestic violence proficiency, and can lead to recommendations that inform organizational needs, planning and implementation around training, practice guidelines, policies, protocols, and supervisory practices.
