If like us you're opposed to the Port of Corpus Christi Authority's (PCCA) plans for an oil export terminal on Harbor Island to service very large crude carriers (VLCCs), then let your representatives know of your opposition. Some key persons to contact are listed at right. Whether you phone, email or write to them here is a sample script that you might want to customize and use:

"Hello, my name is _____ and I'm a constituent of yours. I live in/have a second home in/am a long-time visitor to Port Aransas. I've been following the plans that the Port of Corpus Christi Authority has for an oil export terminal on Harbor Island and I'm strongly opposed. Constructing that terminal would cause immense environmental damage and endanger the fishing and tourism industries on which Port Aransas depends. It would also badly constrain vessel traffic in the narrow channel and present an oil spill hazard. Let them build it offshore and not in our back yard!"
