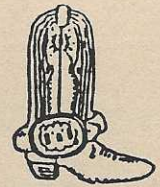

## Opinion Poll

Members who attended the February meeting were asked to participate in a survey. This survey was designed to find out how the membership felt about several issues which have impact on Boots and Buckles. The questions asked were:

3.	58%	34%	8%

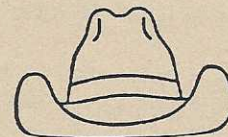
## Membership Time!

The Boots and Buckles board has decided to make all memberships due for renewal in April. This will be a transition year and we are asking you to renew this month. Your rate will be prorated based on your 1988 renewal date. To determine your prorated amount due:

1. Look on your address label for your renewal date. Then use the following schedule to determine the amount due. If your date indicates a past due date, then use April for the amount due.

April	\$11	11 Months
May	\$10	10 Months
June	\$9	9 Months
July	\$8	8 Months
August	\$7	7 Months
September	\$6	6 Months
October	\$5	5 Months
November	\$4	4 Months
December	\$3	3 Months

2. If your address label is correct, just sign the application and prepare check for the amount due.

2. At the January Board of Directors meeting it was decided to remove the limit on membership. This will allow previous members to renew without being on a waiting list. The decision was made to keep the membership dance. Each member may bring one guest without restriction.

3. The status of the jacket order as of 3/9/88 is that the supplier has received all the jackets and is in the process of embroidering them. Shipment should be within a week or two.

4. New badges have been received for new members who joined the club through the middle of February. A second shipment is expected shortly.

5. Membership cards are being ordered from the printer and when received, they will be completed and mailed to new members and those who have renewed their membership.

6. A survey was conducted at our February dance. The questions and results are published in the article titled Opinion Poll.

7. At the March Board of Directors meeting, it was decided to have all membership renewals occur in the same month. Therefore, memberships will be prorated to April, 1989 from you 1988 renewal date. (See renewal article on page 1 in newsletter.)
