
Club News

Club Expectations

Boots "N Buckles has just a few rules for those who attend our dances. Here is a reminder of our standards.

- 1. Be courteous and cooperative with all members, guests and employees. Follow dance etiquette at all times. Dance Etiquette refers to allowing everyone enough dance space. Line dancers use the center of the floor, leaving enough space around the perimeter of the floor for couple dancing. Dancers who are sitting out a dance are enouraged to move off the dance floor to leave the maximum space for dancing.
- 2. Do not take out or bring any alcoholic beverages into the hall. This is a State Law. Remember to return empty glasses and bottles to the bar area. We have no waitresses.
- 3. Young people under 18 must have a responsible adult with them at each dance.
- 4. Young people under 21 are NOT allowed in the bar area except to go to the bathroom. They must have an adult order their soft drinks from the bar.
- 5. If you go outside to cool off, please stay near the front steps. Do not hang out by the cars or wander around the parking lot.
