#### Income:

No earnings have been withdrawn in 2023 from the Baldwin funds.

#### Expenses:

We continued with our commitment to our post-secondary students with an increased gift at Christmas for each of the three students that are currently in college or university. 2023 marked 31 years these gifts have been provided for a total of 260 gifts to our post-secondary students. The 3 recipients were: Jacob Gagnon, Mathieu Gagnon and Connor Hopper.

### **Manse Housing Allowance Fund**

The value of this fund for a number of years has been \$161,825 with the interest transferred to the BSA General account.

By September 2022 this fund was fully invested through the Eastern Ontario Outaouais Regional Council and had on December 31, 2022 a value of \$166,085. On Dec 31, 2023 the value was **\$180,253** for a gain of \$14,168 at 8.53 %. No interest was withdrawn in 2023.

The investments through the Regional Council follow closely the United Church of Canada guidelines. Eight smaller churches like Bethel St. Andrew's had invested about \$1.0 million through the Regional Council at year end.

All 4 funds increased in value by 8.5% during 2023. Very respectable in these economic times.

The St. Columba fund deposited a second \$60,000 by January 1, 2024 for a total of \$125,118.

- All our 4 funds are invested together under the BSA umbrella with 7 other Churches in our region such as Rideau Ferry, Thurso, Glencairn and Winchester.
- At the end of 2023 these 8 Churches had about \$1,000,000 invested through the Regional fund or about 15% of the total.
- Monies are deposited just before the start of the month and withdrawals occur just after month end.
- Typically gains are greater than 4-5 % in a year. Churches are encouraged to withdraw about 4% per year to maintain or grow their investments. This does encourage planned investing.
- Monies can be withdrawn quickly in emergency situations.
- The Regional Treasurer, currently Brian Cornelius, provides Rob Roesler and me with the quarterly reports for tracking purposes covering the Regional funds and those of the 8 Churches.
