

SUDS Tip Sheet: Unit History Record Update

Overview

As the SUDS Data Team continues its work to ensure clients meet eligibility and that any ineligible units are prevented and/or appropriately addressed, new fields have been added to the Unit History Record to help track client eligibility over time. Until now, we have not had a way to determine if a client was eligible for a service on the Date of Service (DoS).

What is the Unit History Record?

This is the completed service unit. Once you have entered your unit information, it's saved as a Unit History record with a SUDS ID of SU-#######. Unit History records can be viewed on the Unit History tab on the SUDS Navigation Pane. Unit History records are what we use when we want to determine how many clients received Chore services this month.

What's New?

We've added informational eligibility fields to the Unit History record. These fields summarize the client's eligibility information on the DoS. The service eligibility and data requirement checkboxes in SUDS only take a client's current eligibility status into account, not their eligibility three months ago when a unit was recorded.

How Can I Use This Information?

By having these fields on the Unit History record, users can run Unit History reports in SUDS to monitor client eligibility. If your agency is trying to rectify ineligible units, a report on these fields can tell users if the client met eligibility criteria on the day they received the service. This removes the guesswork about a client's eligibility regardless of when the service occurred (i.e., did the client meet eligibility six months ago when the unit was recorded).

What's Next?

Nothing. SUDS generates all these fields for us automatically when new service units are entered. They just provide extra context around client eligibility at the time of service.
