



# 2021 Breeding Contract

## Dreaming of Dakar/Cowgirls R Invitd/Louie Villain/Blue Peyo

This certifies \_\_\_\_\_, here referred to as Mare Owner/Agent, has engaged one service to the stallion, \_\_\_\_\_ AQHA # \_\_\_\_\_, for the mare \_\_\_\_\_ Reg # \_\_\_\_\_ for the 2021 breeding season beginning in April.

All payments must be made payable to Hanes Performance Horses.

### *Pre-Breeding Arrangements*

The mare owner must provide the following to HPH, when making a booking:

1. Copy of both sides of registration certificate
2. Completed Information Sheet
3. Copy of signed breeding contract

### *Breeding Arrangements*

1. Stallion is collected, Monday-Wednesday-Friday. It is the mare owner's and his/her veterinarian's responsibility to confirm our breeding/shipping days.
2. To guarantee shipping, mare owner, or agent, must give at least a 24 hour notice of possible semen shipment required HPH, and confirm shipment definitely required 12 hours prior to actual shipment.
3. Every effort will be made to accommodate your mare's breeding time-frame; however, it is the mare owner's responsibility to keep in touch with HPH, so that your veterinarian and ours can get your mare in foal on a timely basis. Failure to adhere to these arrangements may result in missed heats and delayed shipments, at the mare owner's expense. A veterinarian knowledgeable in successful insemination techniques must oversee off site inseminations, in order to maximize the potential of a timely pregnancy.
4. If a mare dies or is deemed unfit to breed during the breeding season, a substitute mare, approved by the stallion owner, may be bred without any additional breeding fee. A new breeding contract must be filled out and sent to HPH for the new mare.
5. The mare owner agrees to have the mare checked by ultrasound no later than 18 days after insemination. If ultrasound is unavailable, mare owner agrees to have the mare checked for pregnancy by licensed veterinarian within 30 days of insemination. Mare owner agrees to provide HPH, with the results of the pregnancy exam no later than 30 days after insemination.
6. Live foal guarantee: A live foal is defined as one that will stand and nurse. If foal is born dead, mare owner agrees to furnish the stallion owner within 7 days a veterinarian's certificate describing the occurrence. In such a case, return privileges will be available for one year only. Rebreds must pay the re-breed booking fee, fill out a new breeding contract and pay any shipping charges applicable. If the mare aborts or fails to conceive, she may return during the current breeding season. If it becomes too late to re-breed a mare during the current season, she may be bred the following year.
7. The breeding season for this contract shall begin April 1 and close July 1, of the year dated on contract.

### ***Shipment Information and additional Charges for Cooled Transported Semen:***

It is the mare owner's responsibility to order a shipment at least 24 hrs in advance.

1. Semen will be sent via Fed-EX (next day arrival) at a rate of \$350 per shipment. Mare owner should check with Fed Ex/UPS for weekend, holiday delivery or customer pickup.
2. HPH shall not be responsible for the COSTS arising from shipments lost, damaged, or delayed in transit, or condition of cooled shipped semen upon delivery. We have no control of the shipment after it leaves our custody.
3. It is the mare owner's responsibility to return a copy of the INSEMINATION CERTIFICATE, signed by administering Veterinarian or Breeding Facility Manager to HPH and forward a signed copy of the certificate to the appropriate Breed Registry.
4. International breeders please note that HPH only ships to the US at this time. HPH does not ship to Canada.

### ***Payment Information:***

All payments may be made by check, Paypal, or with Visa, or Master Card credit cards and must be in US Funds. A 3% processing fee will be added to any payments made by credit card. If paying by check, simply leave credit card space below blank. Please make out all checks to Taylor Hanes.

All shipping and charge fees are subject to change. Payments must be made in full prior to semen shipped.
