Rabies Clinics Protect Pets and People

For many years now, the Humane Society of Wyoming County has been sponsoring twice-yearly, low-cost rabies vaccination clinics for dogs and cats. This year alone, we vaccinated 349 companion animals (180 on May 4 and 169 on October 5). Rabies chairperson Carol Jenkins notes that rabies vaccinations are mandatory by state law for all dogs and cats 3 months of age or over within Pennsylvania. Our clinics provide a low-cost option for pet owners to fulfill this legal requirement, thereby protecting both the pet and human populations from this deadly disease.

Thanks are extended to our many volunteers who give up their Saturdays twice a year to help at these events.

Dr. Colin Jeschke of the Abington Veterinary Center administers a rabies inoculation at our low-cost

clinic held on Saturday, October 5. A total of 169 dogs and cats received their vaccination that day.



HSWC Updates

On June 11, several officers from the HSWC attended an informational symposium at the Radisson Hotel in Scranton, sponsored by the Scranton Area Foundation. The event presented possible sources of funding for organizations assisting with animal welfare within Northeastern Pennsylvania. Since that time, we have applied for two grants to assist with the spaying and neutering of cats, and are anxiously waiting to hear if we were successful.

During September, our Humane Society Police Officer's payroll records were audited by the Pennsylvania State Workman's Insurance Fund. This audit determines if all payroll records are in order. There were no problems found during that audit.

Most years, our annual expenses exceed our income. How do we keep operating? We are able to continue thanks to several gifts and bequests we received in the past. Although we did not have a booth at the Wyoming County Community Fair this year, our Humane Officer, Darrell Sands, volunteered his time at the event to meet with county residents and answer questions.

We often hear, "You don't have a shelter yet, so what do you do?" Plenty, it turns out.

- —Cruelty, neglect, and abuse investigations by a state-certified Humane Society Police Officer.
- —Spay/neuter assistance for struggling pet owners.
- —Emergency care for injured pets when an owner cannot be located.
- —Pet food donations to several local food pantries.
- —Low-cost rabies vaccination clinics (see page 1).
- —Fostering services when local shelters are full.
- —Maintain phone service (messages accepted 24/7), to assist pet owners (and others) with questions on a myriad of topics.
- —Fund raising events to keep us going (we receive no direct tax dollars, nor United Fund monies).
- Education on humane pet care topics.
- —Lending of humane traps (free of charge).
- Maintenance of informational Facebook and web pages.

PLEASE, PLEASE!!

Please be certain that all your own cats, as well as neighborhood stray and feral cats, are spayed or neutered, and up-to-date on rabies vaccines. Local shelters are filled to capacity with unwanted, stray, and homeless cats. We all must do everything we can to reduce that number by spaying and neutering. Lower-cost spay/neuter options are available.

Annual Membership Meeting Notification

The annual membership meeting of the Humane Society of Wyoming County is scheduled for **Wednesday**, **October 30**, at 7:00 p.m. at the Department of Agriculture Building, Route 92, Tunkhannock. Members holding individual or family memberships, and who have paid their current dues by the May 31, 2019, deadline, are entitled to vote on each matter submitted to a vote of the members, including election of officers and Board of Directors, as outlined in our by-laws. Members must vote in person, and no proxy voting will be allowed during election of officers or Board.

Cruelty Cases in Wyoming County

Our Humane Society Police Officer continues to address an abundance of animal cruelty, neglect, abandonment, and abuse in our county. The mistreatment comes from all municipalities, and for all kinds of creatures. Just a few of the calls Officer Sands has responded to since May 1, 2019:

- Neglected donkeys
- Abandoned dog—Forkston Township
- Abused dogs—Laceyville
- Mistreatment of domestic duck
- Large scale animal seizure (other animal welfare organizations involved as well)—Nicholson
- Cat in critical condition on Route 11
- Dog with amputated foot—Washington Township
- Mistreated German Shepherds—Lake Winola
- Cat injured and covered in maggots—Nicholson
- Goat with no shelter or water

Suffering animals suffer in silence until we humans take action on their behalf. The costs associated with training, outfitting, and insuring our humane officer are substantial, but we feel it is an imperative expense. Donations toward this endeavor are most greatly appreciated. If you witness animal abuse, please call us at 570-836-4745. **All calls are confidential.**

<u>Libre's Law in Effect:</u>

Governor Tom Wolf signed "Libre's Law" into effect in 2017. The law increases penalties for animal abuse, increases protection for horses, and prohibits dogs from being tethered outside for more than 9 hours in any 24 hour period (or for more than 30 minutes when temperatures are above 90 or below 32 degrees). It also provides civil immunity to veterinarians, vet techs, and humane society police officers who report suspected cases of animal abuse or neglect.
