Excerpts from MLK's "I Have A Dream" Martin Luther King Address – Summer of 1963

The text quoted below are parts of Dr. Martin Luther King's address in front of the Lincoln Memorial in the Summer of 1963 – 100 years after President Lincoln signed the Emancipation Proclamation January 1, 1863 - and less than a year before the Civil Rights Act of 1964 was passed in January of that year.

I am happy to join with you today in what will go down in history as the greatest demonstration for freedom in the history of our nation.

Five score years ago, a great American, in whose symbolic shadow we stand today, signed the Emancipation Proclamation. This momentous decree came as a great beacon light of hope to millions of Negro slaves who had been seared in the flames of withering injustice. It came as a joyous daybreak to end the long night of captivity...

The marvelous new militancy which has engulfed the Negro community must not lead us to a distrust of all white people, for many of our white brothers, as evidenced by their presence here today, have come to realize that their destiny is tied up with our destiny. And they have come to realize that their freedom is inextricably bound to our freedom. We cannot walk alone...

I have a dream that one day this nation will rise up and live out the true meaning of its creed: "We hold these truths to be self-evident; that all men are created equal..."

I have a dream, that my four little children will one day live in a nation where they will not be judged by the color of their skin but by the content of their character and the desire to transform the jangling discords of our nation into a beautiful symphony of brotherhood...

And when this happens, and when we allow freedom ring, when we let it ring from every village and every hamlet, from every state and every city, we will be able to speed up that day when all of God's children, Black men and white men, Jews and gentiles, Protestants and Catholics, will be able to join hands and sing in the words of the old Negro spiritual, "Free at last! Free at last! Thank God Almighty, we are free at last!"
